WHEREAS, The son of T. Ray and Sylvia Martin Robertson, Dan 4 5 Robertson was born on April 17, 1949, in Perryton, and he was raised in Spearman; after graduating from Spearman High School in 1967, he 6 7 attended West Texas A&M University and later The University of Texas at Austin; Mr. Robertson married the former Donna Freeland on 8 9 July 31, 1971, while they were both completing their studies at UT, and in 1976, he graduated with honors, earning a bachelor's degree 10 11 in government; and

12 WHEREAS, Mr. Robertson worked on various political campaigns, and he was on the staff of Congressman Bob Krueger before 13 14 joining Atlantic Richfield Company, known as ARCO, in 1979; he went on to hold numerous executive positions within the company, 15 16 including director of government affairs; during this time, he and his young family lived in both Houston and Dallas, but they 17 eventually settled in Midland, where Mr. Robertson became president 18 of 180 Petroleum; he was also an investor and a consultant within 19 20 the oil and gas industry; and

21 WHEREAS, Active in numerous organizations, Mr. Robertson 22 served as director of the Texas Lyceum, and he was involved in the 23 Permian Basin Petroleum Association, the Texas Alliance of Energy 24 Producers, the Petroleum Club of Midland, and the Permian Basin

1 Workforce Development Board; he was also a longtime participant on the legislative committee of the Texas Oil and Gas Association, and 2 3 he was the editor of the Oil Report for the Midland Reporter-Telegram; in addition, Mr. Robertson was on the Midland 4 5 Wildcat Committee and the board of the Midland Community Concerts Association, and he was a dedicated supporter of the Permian Basin 6 Petroleum Museum and the Save the Girls collection at the American 7 8 Airpower Heritage Museum; and

9 WHEREAS, Committed to his profession and his community, Dan 10 Robertson touched the lives of countless individuals, and he will 11 be greatly missed by all those who were privileged to know him; now, 12 therefore, be it
