16 colleagues, and he has been a valuable asset to all of the

20 elderly residents in his neighborhood, gathered bottles, sold  
21 newspapers, and shined shoes; while in college, he sold Greek  
22 merchandise to make extra money, and for 20 years, he worked  
23 part-time as a retail sales clerk; and

24           WHEREAS, Mr. Carter has been supported in all of his

1 endeavors by a large and loving family, including his wife,  
2 Cocrecia, his sons, Christopher, Don, and Dondre, his daughter,  
3 Sabrina, and his three grandchildren; in his free time, he enjoys  
4 sports and cooking for his loved ones, who often request "Uncle  
5 Don's" salsa, hot pickles, and pepper sauce; and

6 WHEREAS, Mr. Carter's dedication, professionalism, and  
7 commitment to excellence have greatly benefited his fellow Texans,  
8 and he may indeed reflect with pride on a career well spent as he  
9 prepares to embark on the next exciting chapter of his life; now,
