## RESOLUTION

1 WHEREAS, The boys' varsity soccer team from the Sam Houston 2 Math, Science, and Technology Center in Houston made an outstanding 3 showing during the 2009 season, qualifying for the University 4 Interscholastic League 5A playoffs and advancing to the second 5 round of play; and
