1 WHEREAS, The Greater Dallas Section of the National Council

of Jewish Women has been at the forefront of community leadership

3 and social activism in Dallas for nearly a century; and

WHEREAS, Founded in 1913, the section today is composed of

5 some 1,200 members who volunteer thousands of hours each year to

further the welfare of children, women, the elderly, and families

7 and to advance the cause of social justice; and

8 WHEREAS, The pressing needs of the day have regularly called

9 forth a determined response from this exceptional organization,

10 from providing home-front support during two World Wars to caring

11 for child refugees from Nazi Germany, working to foster interracial

12 understanding, and helping immigrants to achieve citizenship and

13 integrate into American society; and

14 WHEREAS, Many of the projects begun by the Dallas group have

15 become ongoing endeavors or else served as precursors of

16 present-day programs; these include the hot lunch and after-school

17 programs for schoolchildren, the provision of free milk and baby

18 formula, programs to screen for infant hearing problems and to

19 enhance infant brain development, an advocacy program for foster

20 children that evolved into Dallas CASA, and a program to support

21 children who may need to testify in court in felony child abuse

22 cases; in addition, the section introduced the Home Instruction for

23 Parents of Preschool Youngsters program, an initiative to boost

24 academic achievement that has since been adopted by a number of area

- 1 school districts, and pioneered an adult literacy program that now
- 2 ranks as one of the largest and most widely respected in the
- 3 country; and
- WHEREAS, Over the past five years, the Dallas section has
- 5 raised more than \$1 million and distributed those funds to over 40
- 6 projects in the Metroplex; at the same time, the organization
- 7 continues its efforts to educate area citizens about significant
- 8 issues and to develop the skills of community leaders; its own
- 9 members have served on numerous city boards and commissions and on
- 10 the city council, and three have held the office of Dallas mayor;

- 12 WHEREAS, Inspired by Jewish values and committed to
- 13 progressive social action, the women of the Dallas section of the
- 14 NCJW have helped secure for countless individuals the hope of a
- 15 brighter, more promising future, and their far-reaching civic
- 16 engagement is leaving an indelible imprint on a major city of the
- 17 Lone Star State; now, therefore, be it
- RESOLVED, That the House of Representatives of the 81st Texas
- 19 Legislature hereby honor the Greater Dallas Section of the National
- 20 Council of Jewish Women for their distinguished community service
