22 graduation, she plans to attend law school; and

23           WHEREAS, During her tenure as a legislative intern, Ms. Bates  
24 has gained valuable work experience and firsthand knowledge of the

1 governmental process, while also developing insight into the  
2 important issues facing our communities and our state; and

5 Caraway and ably assisted in meeting the needs of constituents, and
