20 Washington, D.C., and he completed studies at City University
21 London; he is currently a second-year student at the Thurgood
22 Marshall School of Law at TSU; and

23 WHEREAS, During his tenure as a legislative intern,
24 Mr. Coefield has gained valuable work experience and firsthand

1 knowledge of the governmental process, while also developing
2 insight into the important issues facing our communities and our
3 state; and

5 skillfully handled a variety of duties in the office of
6 Representative Herrero and ably assisted in meeting the needs of
