18 Texas Southern University with a degree in administration of
19 justice before taking a position with the Social Security
20 Administration, where she worked for four years; she now attends
21 Thurgood Marshall School of Law at TSU and has previously interned
22 at Lambda Legal and the SSA Office of Hearings and Appeals; and

23 WHEREAS, During her tenure as a legislative intern, Ms. Seals
24 has gained valuable work experience and firsthand knowledge of the

1 governmental process, while also developing insight into the
2 important issues facing our communities and our state; and

4 skillfully handled a variety of duties in the office of
5 Representative Thompson and ably assisted in meeting the needs of
6 constituents, and she may reflect proudly on her service as a
