17 Langston University, Ms. Dugger is currently in her second year at  
18 the Thurgood Marshall School of Law; she has been active with a  
19 number of organizations and initiatives, and during the 2008  
20 presidential campaign was involved with Election Protection,  
21 working to ensure that no one was unjustly denied the right to vote;

24 Dugger has gained valuable experience and firsthand knowledge of

1 the governmental process, while also developing insight into the  
2 important issues facing our communities and our state; and
