1       WHEREAS, Sharing a deep bond of love that has spanned more  
2 than six decades, Clarence and Shirley Legler of New Braunfels are  
3 celebrating their 64th wedding anniversary on May 5, 2009; and

4       WHEREAS, Clarence Legler of Plum, Texas, met the former  
5 Shirley Jean May in 1943, in Lincoln, Nebraska, when he attended the  
6 Army Air Corps aeronautical school and she was working a summer job  
7 at the YMCA; although her parents initially opposed the idea of  
8 their 16-year-old daughter dating a military man, the couple fell  
9 in love, and they exchanged the vows of matrimony at Trinity  
10 Lutheran Church in Lincoln on that special day in 1945; over the  
11 course of their marriage, they have found in each other a devoted  
12 life partner; and

13       WHEREAS, Mr. and Mrs. Legler count among their blessings a  
14 fine family that includes three sons, Kip, Kim, and Ken, four  
15 grandchildren, Joseph, Sarah, Krystina, and Kathryn Legler, and one  
16 great-grandson, Brendan Legler, with whom they share the many

19 Mr. Legler helped build the first Convair B-36 "Peacemaker" bomber

7 she continued in the real estate profession and retired as

9 Legler now make their home in New Braunfels, near their family; and

11 Clarence and Shirley Legler can savor a wealth of cherished family  
12 memories and know that the strength of their love and commitment  
13 ensures that many more joyful times await them; now, therefore, be
