## RESOLUTION

1 WHEREAS, The city of San Antonio lost an accomplished

physician with the tragic death of Dr. Michael J. Sanchez on January

3 11, 2009, at the age of 52; and

4 WHEREAS, Dr. Sanchez had been the emergency center medical

5 director at University Hospital since August 2008 and had

6 previously established a notable career in medicine that included

7 service in the United States Air Force and at Southeast Baptist

8 Hospital in San Antonio; and

9 WHEREAS, A New Mexico native, Dr. Sanchez completed his

10 undergraduate studies at the University of Oklahoma and was named a

11 distinguished graduate with honors of that institution in 1984; he

12 went on to serve as a physician's assistant in the air force, and

13 his colleagues, impressed by his abilities, recommended that he

14 attain a medical degree; after earning his M.D. in 1990 from the

15 University of New Mexico School of Medicine, he completed his

16 internship and residency at Wilford Hall Medical Center at Lackland

17 Air Force Base; and

WHEREAS, Dr. Sanchez served as research director of the Joint

19 Military Medical Command at Fort Sam Houston from 1996 to 1998 and

20 then spent three years directing the Emergency Medical Department

21 at the United States Air Force Academy; during that period, he was

22 selected to be part of the medical team aboard Air Force One and

23 accompanied President Bill Clinton to Pakistan and India; in honor

24 of his distinguished service, he received the Air Force

- 1 Commendation Medal in 1998; and
- 2 WHEREAS, After concluding his air force service in 2000, he
- 3 became an emergency physician for Baptist Health System in San
- 4 Antonio, and in 2003 was named the director of emergency medicine at
- 5 Southeast Baptist Hospital; he joined the staff at The University
- 6 of Texas Health Science Center at San Antonio in 2006 as an
- 7 assistant professor before assuming his duties as the hospital's
- 8 emergency center medical director two years later; in his first
- 9 five months in that position, Dr. Sanchez had brought about reforms
- 10 to enhance efficiency and customer service and reduce waiting times
- 11 for patients, and he was at work on plans to institute a residency
- 12 program in emergency medicine; and
- WHEREAS, In all of his endeavors, Dr. Sanchez enjoyed the
- 14 love and support of his wife, Apelle, and his daughters, Carla
- 15 Parker and Suzanne Sanchez; he took great pleasure in spending time
- 16 with his family and also enjoyed a number of hobbies, including
- 17 sailing and playing the drums; and
- 18 WHEREAS, Known for the exceptional enthusiasm and dedication
- 19 he brought to his work as well as his extensive medical knowledge
- 20 and managerial skill, Michael Sanchez made a positive difference in
- 21 many lives over the course of his career, and he will be warmly
- 22 remembered and greatly missed by all who had the good fortune to
- 23 know him; now, therefore, be it

- 25 Legislature hereby pay tribute to the life of Dr. Michael J. Sanchez
- 26 and extend deepest condolences to his family: to his wife, Apelle
