6 earned a bachelor's degree from North Texas State University in

7 1954; she married John Anderson two years later, and the couple made

8 their home in Lubbock, where Dr. Anderson served as a professor of

10 WHEREAS, Ms. Anderson soon distinguished herself through her

outstanding volunteerism in behalf of numerous causes; her

contributions to the city of Lubbock alone are extraordinary, with

13 the Urban Renewal Board, the South Plains Regional Workforce

14 Development Board, the Lubbock Area United Way Board, the South

15 Plains Area Agency on Aging Advisory Council, and the Saint Mary of

16 the Plains Hospital Foundation Board all benefiting from her

17 membership; moreover, she was a founding member of the South Plains

18 Food Bank, and she shared her time and talents with PEOPLE FIRST,

19 the Lubbock Rape Crisis Center, the South Plains AIDS Resource

20 Center, the Lubbock Independent School District Committee on

21 Excellence, and the city's planning and zoning commission; and

WHEREAS, An esteemed leader on the state and national level

- 6 the Texas Committee for the Humanities and the Texas Commission on
- 7 Women; she also gave generously as a board member of the Center for
- 8 Public Policy Priorities for more than a decade; and
- 9 WHEREAS, Recognized often for her tireless efforts, Ms.
- 10 Anderson was the recipient of numerous honors, including the George
- 11 Mahon Award from the Lubbock chapter of the Association for Women in
- 12 Communications, the United Way Rita Harmon Volunteer Service Award,
- 13 the League of Women Voters State President's Award, and the
- 14 National League of Women Voters Education Fund Leaders Award, among
- 15 others; and
- 16 WHEREAS, Ms. Anderson was further known as a dedicated wife
- 17 and mother, a faithful congregant of St. John's Methodist Church in
- 18 Lubbock, and a lifelong learner who earned a master's degree from
- 19 Texas Tech University in 1973; and
- 20 WHEREAS, Though it is impossible to gauge the full effect of a
- 21 person's life, some individuals leave their unmistakable mark on
- 22 the world as they move through it, and Betty Price Anderson's legacy
- 23 of compassion, vision, and commitment to her fellow Texans will be
- 24 cherished for years to come; now, therefore, be it
