admired community leader with the passing of Edwin R. Carseth on
April 26, 2009, at the age of 89; and

WHEREAS, Born on October 30, 1919, to Arthur and Elsie Roehr Carseth in Chicago, Edwin Carseth attended Wilbur Wright Junior College and Northwestern University; he answered his nation's call to duty with service in the U.S. Army Air Corps during World War II and conducted supply flights over the Himalaya Mountains in the China-Burma-India theater; and

WHEREAS, Mr. Carseth joined the air force reserves after the 10 11 war and continued to serve until 1957; during his years in uniform, 12 he earned the Distinguished Flying Cross, the Air Medal, the American Campaign Medal, the Asiatic-Pacific Campaign Medal with 13 14 four Bronze Service Stars, and the World War II Victory Medal; drawing on his aviation experience, he became a flight examiner for 15 the Federal Aviation Administration and founded the Aviation 16 Division of the Outboard Marine Corporation, serving as the 17 company's chief pilot for nearly four decades; and 18

WHEREAS, In all his endeavors, Mr. Carseth enjoyed the love and support of his wife, the former Margaret Walls, with whom he shared more than 50 years of marriage; the couple had one daughter, Suzette, who passed away in 1982; and

23 WHEREAS, Mr. Carseth and his family lived in Wisconsin for a 24 number of years, where he was active in many community

1 organizations, serving as a charter member of the Milwaukee Chapter of the Quiet Birdmen Association and the Kiwanis Golden K of Elm 2 Grove, as well as being a member of the American Legion, Disabled 3 American Veterans, and the Elks Club of Milwaukee; after he and Mrs. 4 5 Carseth relocated to Kerrville in 1987, he helped charter the Hill Country Chapter of the Retired Officers Association and started the 6 Kerrville Quiet Birdmen Hangar; moreover, he volunteered at the 7 8 Kerrville VA hospital through Kiwanis and was a member of Notre Dame 9 Catholic Church; and

10 WHEREAS, Edwin Carseth lived a full and purposeful life, and 11 though he will be deeply missed, his legacy of service to his 12 country and his community will long resonate in the hearts of all 13 those fortunate enough to have known him; now, therefore, be it
