

R E S O L U T I O N

1 WHEREAS, The family and friends of U.S. Army Corporal Juan
2 Manuel Lopez, Jr., of San Antonio suffered an immeasurable loss
3 with his death in Iraq on August 13, 2007, at the age of 23; and

4 WHEREAS, Assigned to the 5th Battalion, 82nd Field Artillery
5 Regiment, 4th Brigade Combat Team, 1st Cavalry Division, out of
6 Fort Bliss, Corporal Lopez died of wounds sustained when his
7 vehicle was struck by a roadside bomb in Qayyarah, Iraq; he was
8 posthumously awarded the Purple Heart and the Bronze Star; and

9 WHEREAS, Juan Lopez was born in Mt. Holly, New Jersey, on
10 August 9, 1984, to Juan Manuel Lopez, Sr., and Tina Marie Murph
11 Criss; raised in Florence, South Carolina, he attended South
12 Florence High School and graduated from Poynor Adult and Community
13 Education Center in 2005; and

14 WHEREAS, A man of strong religious faith, Corporal Lopez was
15 a member of Faith Kingdom Builders Outreaching Ministries in
16 Florence, and he was also affiliated with the Inner Court Apostolic
17 Church in Jesus Christ in Florence and Faith Mission Outreach in
18 Texas; and

19 WHEREAS, Exemplifying the highest ideals of the U.S. armed
20 forces, Juan Lopez inspired others with his fortitude and courage,
21 and although his passing has left a void in the lives of his loved
22 ones, they will forever carry their memories of this heroic young
23 soldier close in their hearts; now, therefore, be it
