14 WHEREAS, A man of strong religious faith, Corporal Lopez was 15 a member of Faith Kingdom Builders Outreaching Ministries in 16 Florence, and he was also affiliated with the Inner Court Apostolic 17 Church in Jesus Christ in Florence and Faith Mission Outreach in 18 Texas; and

WHEREAS, Exemplifying the highest ideals of the U.S. armed forces, Juan Lopez inspired others with his fortitude and courage, and although his passing has left a void in the lives of his loved ones, they will forever carry their memories of this heroic young soldier close in their hearts; now, therefore, be it
