- 2 United States Army Staff Sergeant Jason Logan Brown of Magnolia,
- 3 who died in Iraq on April 17, 2008, at the age of 29; and
- WHEREAS, An engineer sergeant with the Special Forces, Jason
- 5 Brown was assigned to Company B, 3rd Battalion, 5th Special Forces
- 6 Group (Airborne), based at Fort Campbell in Kentucky; he was
- 7 serving his second tour of duty in Iraq when he was mortally wounded
- 8 while conducting combat operations in Sama Village; and
- 9 WHEREAS, This valiant soldier was born on September 30, 1978,
- 10 in Dallas and graduated from DeSoto High School in 1997; after
- 11 attending Cedar Valley College, he received a bachelor's degree in
- 12 criminal justice from Sam Houston State University in 2002; and
- WHEREAS, Jason Brown fulfilled a long-held dream when he
- 14 enlisted in the army as a candidate for the Special Forces on March
- 15 25, 2003; he earned the green beret the following year, and his
- 16 service in that elite force was a source of great pride to both
- 17 Sergeant Brown and his family; and
- 18 WHEREAS, Among the numerous awards conferred on Sergeant
- 19 Brown were the Bronze Star, the Purple Heart, the Meritorious
- 20 Service Medal, and the Army Commendation Medal; and
- 21 WHEREAS, Beloved for his generosity, his exuberance, and his
- 22 irrepressible sense of humor, Jason Brown brought joy into the
- 23 lives of his family and many friends; in his free time, he relished
- 24 spending time outdoors and especially enjoyed hunting, fishing, and

- 1 working in his yard; and
- WHEREAS, Although his mission in Iraq was a hazardous one,
- 3 Sergeant Brown took its dangers in stride and performed his mission
- 4 with exemplary dedication and professionalism; his unwavering
- 5 integrity and devotion to this country reflected the highest ideals
- 6 of the Special Forces, and his fellow citizens owe him a debt of
- 7 gratitude that the passage of time can never diminish; now,
- 8 therefore, be it
- 9 RESOLVED, That the House of Representatives of the 81st Texas
- 10 Legislature hereby pay tribute to the life of United States Army
- 11 Staff Sergeant Jason Logan Brown and extend sincere sympathy to the
- 12 members of his family: to his daughter, Alyssa Gomez; to his
