1 WHEREAS, The life of an esteemed attorney and judge drew to a 2 close with the passing of the Honorable Scott Alan Ozmun of Austin

3 on May 8, 2009, at the age of 50; and

WHEREAS, Scott Ozmun established a distinguished career as a

5 civil trial lawyer that extended for more than two decades, and he

6 took a leadership role in the Travis County Democratic Party as well

7 as many professional organizations; in 2008, he was elected judge

8 of the 353rd District Court, serving in that position until the time

9 of his death; and

WHEREAS, Born on September 30, 1958, in Cleveland, Ohio,

11 Judge Ozmun spent several years in New York early in his life; he

12 completed his undergraduate studies at Georgetown University,

13 where he served as student body president during his senior year,

14 and graduated with honors from The University of Texas School of Law

15 in 1985; and

16 WHEREAS, After working as a briefing attorney for Justice

17 William Kilgarlin of the Texas Supreme Court, he entered private

18 practice and became a partner in the Austin law firm that is now

19 known as Whitehurst, Harkness, Brees, Cheng & Imhoff; renowned for

20 the skilled and compassionate service he provided to his clients,

21 he was a respected member of the legal community and served on the

22 boards of Volunteer Legal Services of Central Texas, the Legal Aid

23 Society of Central Texas, and the Austin Young Lawyers Association;

24 moreover, he was president-elect of the Austin chapter of the

- 2 directors for the Austin Bar Association and the Texas Trial
- 3 Lawyers Association; and
- WHEREAS, Judge Ozmun's involvement in electoral politics
- 5 included service as a precinct chair and as a member of the finance
- 6 council for the Travis County Democratic Party, and he was the
- 7 organization's party chair from 2000 to 2004; nonetheless, he had
- 8 the ability to transcend partisan divisions and counted many
- 9 Republicans among his friends; and
- 10 WHEREAS, In all of his endeavors, he enjoyed the love and
- 11 support of his wife, Beth, and his daughters, Delaney and Kendall;
- 12 through the years, he was an avid sports fan, cheering on the
- 13 Buffalo Bills and the athletic teams of his alma maters, Georgetown
- 14 and UT; and
- 15 WHEREAS, Those Texans who give freely of their time and
- 16 talents to benefit the greater community make the world a better
- 17 place through their actions and their example, and Scott Ozmun
- 18 leaves behind a legacy that will resonate for many years to come;
