- WHEREAS, "Skip" Dees was born in Dallas on June 23, 1942, to
- 4 Allen D. Dees and Sadie Sampsell Dees; he grew up in Kaufman, where
- 5 he graduated from high school in 1960, and went on to earn a
- 6 bachelor's degree in electrical engineering from Texas A&M
- 7 University in 1965; and
- 8 WHEREAS, Mr. Dees enjoyed a long and distinguished career in
- 9 the petroleum industry, working for Texaco from 1965 until his
- 10 retirement in 2002; as a petroleum engineer and an engineering
- 11 manager, he was posted to a number of locations in Texas, and he
- 12 also worked in Trinidad in the West Indies; and
- WHEREAS, In 1981, he organized Texaco's Regulatory
- 14 Compliance Department for the Houston division and three years
- 15 later became the regulatory compliance manager in Midland; in 1994,
- 16 he was appointed the company's regulatory affairs manager, a
- 17 position that entailed responsibility for Texas regulatory and
- 18 legislative matters; and
- 19 WHEREAS, Active in his profession, Mr. Dees served as chair
- 20 of the Texas Oil and Gas Association Production Environmental
- 21 Committee and as a member of its Regulatory Practices Committee; in
- 22 1995, he was the first recipient of the TxOGA Exemplary Service
- 23 Award; and
- 24 WHEREAS, Despite his many professional responsibilities,

- 1 this caring gentleman found time to be active with the Boy Scouts as
- 2 a den leader and scoutmaster; he was also an elder, deacon, and
- 3 committee member in the Presbyterian Church, and he taught Sunday
- 4 school in Midland for many years; and
- 5 WHEREAS, In addition, Mr. Dees was a 32nd degree Scottish
- 6 Rite Mason and held several important offices with the York Rite
- 7 organizations; moreover, he was active in the Knights Templar
- 8 educational and medical foundations, and he was the recipient of
- 9 the Knights Templar Cross of Honor, the Knight Commander of the
- 10 Temple, and the Golden Keystone Award; and
- 11 WHEREAS, Skip Dees lived a full and generous life as a leading
- 12 member of his profession and as an engaged member of his community,
- 13 and he will forever be remembered with great admiration and
- 14 affection by all those who knew and loved him; now, therefore, be it
