1 WHEREAS, Lionel Aron Peña of Edinburg has distinguished

2 himself as a highly regarded attorney and civic leader; and

3 WHEREAS, The son of Baltazar and Guadalupe Peña, Lionel Aron

5 the valedictorian of the Edcouch-Elsa High School Class of 1954; he

6 also joined the National Guard, achieving the rank of sergeant, and

7 he was president of the pre-law society at The University of

8 Texas--Pan American, graduating with honors from the institution in

9 1957; three years later, he earned a juris doctor degree from the UT

10 Austin School of Law; and

11 WHEREAS, Settling in Edinburg, Mr. Peña joined the firm of

12 Rankin, Kilgore, Cherry, and Martinez, and in 1962, he and his

13 partners launched a practice that would become Peña, McDonald,

14 Prestia, and Ornelas; in the late 1970s, Mr. Peña was admitted as an

15 attorney and counselor of the U.S. Court of Appeals and the Supreme

16 Court of the United States, and he was certified in criminal law by

17 the Texas Board of Legal Specialization in December 1981; he later

18 obtained licensure to practice in the Southern and Western District

19 Courts of Texas and in Michigan, Illinois, and Arkansas; he was the

20 attorney for both the City of Edinburg and the Edinburg

21 Consolidated School District for 15 years, and he represented the

22 Edinburg Hospital for two decades; he was also on the board of the

23 Hidalgo County Criminal Defense Lawyers Association; and

24 WHEREAS, Active in many local organizations, Mr. Peña is a

- 1 past president of the Edinburg Jaycees, the Edinburg Chamber of
- 2 Commerce, the Corpus Christi Diocesan Council of Catholic Men, and
- 3 the Lions Club, which he has been involved with for 40 years; he has
- 4 also served on the board of the Rio Grande Valley Partnership and on
- 5 the Edinburg City Commission, and he was mayor pro tempore for six
- 6 years; and
- WHEREAS, A loving patriarch, Mr. Peña has been married to his
- 8 wife, Sylvia, since 1958, and they have shared the joy of welcoming
- 9 into their family six children, Lionel Aron, John Eric, Mark, Evie,
- 10 Jeff, and Louis Dominic; he takes great pleasure in spending time
- 11 with his loved ones, including his 25 grandchildren and 5
- 12 great-grandchildren, and in traveling, playing tennis, and
