1 WHEREAS, Residents of Athens lost an admired civic leader and 2 a cherished friend with the passing of William C. "Dub" McCarty on 3 May 22, 2009, at the age of 79; and

WHEREAS, Born to Maggie Mae and Dorsey McCarty on June 13, 4 5 1929, in Scurry County, Dub McCarty graduated from Lamesa High School and went on to serve in the United States Army during the 6 7 Korean War; on his return to Lamesa, Mr. McCarty entered the retail clothing business and became the proprietor of Mac's Men's Wear, and 8 9 he later worked in corporate group insurance management in Dallas; 10 in 1985, he launched a fire and casualty insurance business in Cedar 11 Creek, and he opened an additional office in Athens, where he 12 settled in 1999; and

13 WHEREAS, Mr. McCarty was active in both the Cedar Creek and 14 Athens Kiwanis Clubs, as well as the Athens Rotary Club, and he was a longtime Boy Scout troop leader; in addition, he helped establish 15 the Library at Cedar Creek Lake and served on its first board of 16 directors, and he was on the advisory committee that oversaw the 17 expansion of the Henderson County Jail; he was also a past president 18 of the Cedar Creek Lake Area Chamber of Commerce and a recipient of 19 the group's Lifetime Achievement Award, and he was the chair of the 20 21 Henderson County Republican Party from 1999 to 2007; moreover, he was a member of the Scottish Rite and the Order of the Eastern Star 22 23 and a 32nd degree Mason; and
