WHEREAS, Successfully meeting the needs of the legislature

2 over the course of a 140-day regular session is a challenging task taken on every two years by the staff of the legislative support 3 agencies, including the Texas Legislative Council; and 4 5 WHEREAS, Each odd-numbered year, legislators travel to the Capitol from across the Lone Star State to represent their 6 7 constituents, yet they must stay connected with the folks back home throughout their tenure in Austin; helping them to maintain that 8 tie are the members of the council's information systems division, 9 whose skilled technical services crew ensures that offices are 10 equipped with needed PCs, printers, and software; before the 11 12 session even began, these personnel installed or relocated equipment in 29 district offices and moved 129 Capitol offices; the 13 14 division's Computer Support Center provides training designed to serve everyone from the most savvy client to those with little to no 15 experience, and the division's technical support staff and CSC 16 operators are standing by to help them all, ready to lend their 17 expertise over the phone or to dispatch one of the council computer 18 consultants to an office just in the nick of time; so far this 19 session, the staff has answered approximately 23,000 calls and 20 21 provided training to 93 percent more clients; others among the IS 22 staff are at work developing and supporting such custom network and web applications as LMS, CMS, MSS, TLIS, and TLO to accomplish ever 23 24 more diverse tasks; and

1 WHEREAS, The hardworking attorneys, legal assistants, editors, and support staff of the legal division are one by one 2 3 helping to craft the proposed laws of the Lone Star State; to that end, legal staff members have produced some 10,600, or 32.5 percent 4 5 more, bills and constitutional amendments and approximately 12,800, or 21 percent more, amendments, substitutes, conference 6 committee reports, and miscellaneous drafts; greatly contributing 7 8 to the process are members of the division's legal editing team, who not only work on each draft produced by the agency but also perform 9 10 a dual role by carrying out the engrossing and enrolling duties for the house; in that capacity, they have engrossed more than 1,300 and 11 enrolled close to 560 house bills and constitutional amendments and 12 over 2,500 house concurrent and simple resolutions, with the bulk 13 14 of the end-of-session enrollment work still to come; and 15 WHEREAS, The research division of the TLC is composed of policy and statistical analysts, writers, webmasters, mapmakers, 16 17 and database specialists; during the session, these multitasking staffers have spent their time handling a 25 percent increase in 18 19 research, data, and map requests from the legislature and the public while also producing more than 600 senate amendment and 20 conference committee side-by-side analyses in the waning days of 21 the session, some 4,650 bill analyses for house committees, and 22 23 approximately 4,700 policy, congratulatory, and memorial 24 resolutions; they also update election and geographic databases and prepare other useful publications and develop websites to help new 25

- 5 session are the employees of the data transcription, graphics,
- 6 proofreading, print shop, and final processing sections; also
- 7 central to the mix is the document distribution section, which
- 8 distributes more than 100,000 copies of bills and resolutions to
- 9 the legislative community and the public; and

- 11 not for the policy and planning division, whose personnel played a
- 12 vital role in helping to hire the 130 extra employees needed agency

- 16 of the agency's divisions running smoothly during the session;
- 17 composed of the executive team and the accounting and purchasing

- 20 operations of the agency and manages the myriad everyday tasks
- 21 required to ensure TLC staff with the resources they need to get the
