## Suspending limitations on conference committee jurisdiction, H.B. No. 3347 (Truitt/Duncan)

## RESOLUTION

- BE IT RESOLVED by the House of Representatives of the State of
- 2 Texas, 81st Legislature, Regular Session, 2009, That House Rule 13,
- 3 Section 9(a), be suspended in part as provided by House Rule 13,
- 4 Section 9(f), to enable the conference committee appointed to
- 5 resolve the differences on House Bill 3347 (plan qualification
- 6 provisions for and certain supplemental payments and health
- 7 insurance deductions under the Teacher Retirement System of Texas)
- 8 to consider and take action on the following matter:
- 9 House Rule 13, Section 9(a)(4), is suspended to permit the
- 10 committee to add the following new SECTION 5 to the bill:
- 11 SECTION 5. (a) The Teacher Retirement System of Texas
- 12 shall make a one-time supplemental payment of a retirement or death
- 13 benefit as provided by this section.
- 14 (b) The supplemental payment is payable to each eligible
- 15 annuitant not later than January 2010 and, to the extent
- 16 practicable, on a date or dates that coincide with the regular
- 17 annuity payment payable to each eligible annuitant.
- 18 (c) The amount of the supplemental payment is equal to the
- 19 lesser of:
- 20 (1) the gross amount of the regular annuity payment to
- 21 which the eligible annuitant is otherwise entitled for the month of
- 22 December 2009; or
- 23 (2) \$500.
- 24 (d) The supplemental payment is payable without regard to

- 1 any forfeiture of benefits under Section 824.601, Government Code.
- 2 The Teacher Retirement System of Texas shall make applicable tax
- 3 withholding and other legally required deductions before
- 4 disbursing the supplemental payment. A supplemental payment under
- 5 this section is in addition to and not in lieu of the regular
- 6 monthly annuity payment to which the eligible annuitant is
- 7 otherwise entitled.
- 8 (e) Subject to Subsection (f) of this section, to be
- 9 eligible for the supplemental payment, a person must be, for the
- 10 month of December 2009, and disregarding any forfeiture of benefits
- 11 under Section 824.601, Government Code, an annuitant eligible to
- 12 receive:
- 13 (1) a standard retirement annuity payment;
- 14 (2) an optional retirement annuity payment as either a
- 15 retiree or beneficiary;
- 16 (3) a life annuity payment under Section
- 17 824.402(a)(4), Government Code;
- 18 (4) an annuity for a guaranteed period of 60 months
- 19 under Section 824.402(a)(3), Government Code; or
- 20 (5) an alternate payee annuity payment under Section
- 21 804.005, Government Code.
- 22 (f) If the annuitant is a retiree or if the annuitant is a
- 23 beneficiary of a retiree who selected an optional retirement
- 24 payment plan, to be eligible for the supplemental payment, the
- 25 effective date of the retirement of the member of the Teacher
- 26 Retirement System of Texas must have been on or before December 31,
- 27 2008. If the annuitant is a beneficiary under Section

- 1 824.402(a)(3) or (4), Government Code, to be eligible for the
- 2 supplemental payment, the date of death of the member of the
- 3 retirement system must have been on or before December 31, 2008.
- 4 The supplemental payment shall be made to an alternate payee who is
- 5 an annuitant under Section 804.005, Government Code, only if the
- 6 annuity payment to the alternate payee commenced on or before
- 7 December 31, 2008. The supplemental payment is in addition to the
- 8 guaranteed number of payments under Section 824.402(a)(3),
- 9 Government Code, Section 824.204(c)(3) or (4), Government Code, or
- 10 Section 824.308(c)(3) or (4), Government Code, and may not be
- 11 counted as one of the guaranteed monthly payments.
- 12 (g) The supplemental payment does not apply to payments
- 13 under:
- 14 (1) Section 824.304(a), Government Code, relating to
- 15 disability retirees with less than 10 years of service credit;
- 16 (2) Section 824.804(b), Government Code, relating to
- 17 participants in the deferred retirement option plan with regard to
- 18 payments from their deferred retirement option plan accounts;
- 19 (3) Section 824.501(a), Government Code, relating to
- 20 retiree survivor beneficiaries who receive a survivor annuity in an
- 21 amount fixed by statute; or
- 22 (4) Section 824.404(a), Government Code, relating to
- 23 active member survivor beneficiaries who receive a survivor annuity
- 24 in an amount fixed by statute.
- 25 (h) Except as provided by this section, the board of
- 26 trustees of the Teacher Retirement System of Texas shall determine
- 27 the eligibility for and the amount and timing of a supplemental

- 1 payment and the manner in which the payment is made.
- 2 (i) The supplemental payment is contingent on sufficient
- B funds being appropriated from general revenue to the Teacher
- 4 Retirement System of Texas for this purpose and may not be paid from
- 5 trust funds.
- 6 Explanation: This addition is necessary to provide a
- 7 supplemental payment to eligible retirees and beneficiaries who
- 8 receive payments from the Teacher Retirement System of Texas.
