15	(A) is owned or leased by a governmental entity;
16	(B) is owned or leased by the police department
17	of a private institution of higher education that commissions peace
18	officers under Section 51.212, Education Code; or
19	(C) is:
20	(i) a private vehicle owned or leased by the
21	<pre>peace officer; and</pre>
22	(ii) approved for use for law enforcement
23	purposes by the head of the law enforcement agency that employs the
2/1	neace officer or by that nerson's designee provided that use of

- 2 adopted by the commissioners court of a county under Section
- 3 170.001, Local Government Code, and that the private vehicle may

- 6 Transportation Code, unless the vehicle is marked.

- Sec. 37.2121. MEMORANDA OF UNDERSTANDING AND MUTUAL AID
- 27 AGREEMENTS. (a) The center shall identify and inform school

- 3 <u>responders, with whom school districts should</u> customarily make
- 4 efforts to enter into memoranda of understanding or mutual aid

- 8 of understanding and mutual aid agreements between school districts
