- 5 Service Medal and the Lone Star Distinguished Service Medal, and he
- 6 was a parliamentarian for the National Guard Association of Texas

- 9 judge for Precinct 406 in Travis County, and he has also worked as a
- 10 staff attorney for Bob Honts Properties, Inc., and as a senior
