- 1 WHEREAS, Family and friends are mourning the loss of Albert
- 2 Abraham of Marshall, who died on February 22, 2009, at the age of
- 3 89; and
- WHEREAS, Albert Abraham was born in Marshall on November 19,
- 5 1919, to Louis Charles Abraham and Helena Haddad Abraham; he
- 6 graduated from Marshall High School and the College of Marshall,
- 7 now East Texas Baptist University; and
- 8 WHEREAS, Answering his nation's call to duty during World War
- 9 II, Mr. Abraham enlisted in the U.S. Army Air Forces and was trained
- 10 as a fighter pilot; after initially patrolling the airspace over
- 11 the Panama Canal, he was transferred to the China-Burma-India
- 12 theater, where he flew P-51 Mustang fighters in close support of
- 13 Allied ground troops, destroying enemy installations from the air;
- 14 at one point during the war, this brave American flew 35 combat
- 15 missions in 53 days; he was later captured and spent time as a
- 16 prisoner of war; and
- WHEREAS, Mr. Abraham's courage and sacrifice during the war
- 18 were recognized with the Distinguished Flying Cross, the Air Medal
- 19 with one Oak Leaf Cluster, the Purple Heart, the American Defense
- 20 Service Medal, the Asiatic-Pacific Campaign Medal with two Bronze
- 21 Stars, the American Campaign Medal with one Bronze Star, the Unit
- 22 Citation Badge, the World War II Victory Medal, the Presidential
- 23 Testimonial, and the POW Medal; and
- 24 WHEREAS, Discharged after the war with the rank of major,

- 1 Albert Abraham returned to Marshall and married Adrah Marie Ryan in
- 2 1946; he owned and operated Abraham Grocery until his retirement in
- 3 1982 and he played an active role in his community as a member of
- 4 Masonic Lodge No. 22, the Shriners Club, and the Optimist Club; he
- 5 was also a member of the Gideon Society, and he sat on the alumni
- 6 board of East Texas Baptist University; and
- 7 WHEREAS, Deeply loyal to his fellow service members, Mr.
- 8 Abraham held an appointment to the Veterans' Land Board of the
- 9 General Land Office, and he earned a certificate of recognition for
- 10 his work in behalf of veterans in the Lone Star State; he was a
- 11 member of both the American Legion and the Veterans of Foreign Wars;
- 12 and
- WHEREAS, Albert Abraham dedicated his life to serving his
- 14 family, his community, and his nation, and he will forever be
- 15 remembered with warm affection by all those who knew and loved him;
- 16 now, therefore, be it
- 17 RESOLVED, That the House of Representatives of the 81st Texas
- 18 Legislature hereby pay tribute to the life of Albert Abraham and
- 19 extend sincere condolences to the members of his family: to his wife
- 20 of 62 years, Adrah Abraham; to his daughter, Theresa Crawford; to
- 21 his son, Charles Abraham, and his wife, Lisa; to his sister, Joyce
- 22 Haddad; to his sister-in-law, Doris Abraham; to his grandchildren,
