1 WHEREAS, Family and friends mourn the loss of Raymond Risk,
2 Sr., of Sherman, who died on June 21, 2008, at the age of 85; and

3 WHEREAS, Raymond Risk was born on April 28, 1923, to Julia
4 David and John Naif Risk; after graduating from Sherman High School
5 in 1941, he attended Austin College; he was joined in matrimony to
6 Lillian Risk, and they became the parents of three children, Naif,
7 Raymond, and Sarah; and

8 WHEREAS, Mr. Risk was a decorated soldier with the U.S. Army
9 during World War II, serving as a sergeant under General George
10 Patton in the 94th Medical Gas Treatment Battalion of the 3rd Army;
11 and

12 WHEREAS, Returning to civilian life in Sherman after the war,
13 he took over Risk Shoe Store and Shoe Repair from his father; he ran
14 the shop successfully until his retirement in 2002, and this
15 well-known local business is currently operated by Mr. Risk's son,
16 Naif; and

17 WHEREAS, Throughout his life, Raymond Risk continued to honor
18 his military service as a member of the American Legion, AMVETS, the
19 Disabled American Veterans, and the Veterans of Foreign Wars; and

20 WHEREAS, This esteemed Texan also shared his time with the
21 Sherman Noon Lions Club; a member for 61 years, he held several
22 offices, including president, was recognized as a life member of
23 the Julien C. Hyer Lions Youth Camp and the Texas Lions Camp, and
24 was named a Melvin Jones Fellow; in addition, Mr. Risk was a

1 dedicated member of St. Stephen's Episcopal Church and the Odd
2 Fellows; and

3 WHEREAS, A brave soldier, a community leader, and a respected
4 businessman, Raymond Risk, Sr., excelled in each of these roles,
5 and his long and productive life serves as an inspiration to those
6 who were fortunate enough to share in his love and friendship; now,
7 therefore, be it

8 RESOLVED, That the House of Representatives of the 81st Texas
9 Legislature hereby pay tribute to the memory of Raymond Risk, Sr.,
10 and extend sincere condolences to the members of his family: to his
11 son, Naif Risk, his wife, Cindy, and their niece, Lauren Stephens;
12 to his son, Raymond Risk, his wife, Nancy, and their son, Noah; to
13 his sister, Jeanette Snyder; to his brother, William Risk, and his
14 wife, Margaret Ann; to his in-laws, Norma Oren and her husband, Bob,
15 Ernest Horany and his wife, Eileen, and Julia Waldrop and her
16 husband, Kenneth; to his dear friend and companion, Mary Moses; and
17 to his other relatives and friends; and, be it further
