1           WHEREAS, Alyssa Eacono has ably served her fellow Texans as  
2 chief of staff in the office of State Representative Will Hartnett  
3 since December 2006; and

4           WHEREAS, During both the 80th and 81st Legislatures, Ms.  
5 Eacono has demonstrated outstanding leadership and expertise in  
6 handling myriad diverse tasks; her professionalism has assured the  
7 efficient operation of the office, allowing her employer to  
8 effectively devote his attention to the urgent issues facing the  
9 citizens of the Lone Star State; and

11 native played hide-and-go-seek in the Capitol when it was open 24

21 for State Representative Barry Telford, and as a clerk for the House  
22 Committee on Financial Institutions; moreover, she developed  
23 important skills as an analyst for the Public Utility Commission of  
24 Texas, and she has shared her knowledge with others as an associate

2 WHEREAS, Dedicated to giving back to the greater community,  
3 Ms. Eacono has served as a mentor for Big Brothers Big Sisters for  
4 11 years, and she is a board member of the Samaritan Center for  
5 Counseling and Pastoral Care and a volunteer for Meals on Wheels; in  
6 addition, she has distinguished herself as a member of the Mayor's  
7 Committee for People with Disabilities and the Public Advisory  
8 Committee of the International Electric Power Research Institute;

12 fitting to take this opportunity to recognize her for a job well
