19	Sec. 1379.002. APPLICABILITY OF CHAPTER. (a) This chapter
20	applies only to a health benefit plan that provides benefits for
21	medical or surgical expenses incurred as a result of a health
22	condition, accident, or sickness, including an individual, group,
23	blanket, or franchise insurance policy or insurance agreement, a
24	group hospital service contract, or an individual or group evidence

2	(1) an insurance company;
3	(2) a group hospital service corporation operating

2	Sec. 1379.003. APPLICABILITY TO CERTAIN GOVERNMENT
3	PROGRAMS. To the extent allowed by federal law, the state Medicaid
4	program, and a managed care organization that contracts with the
5	Health and Human Services Commission to provide health care
6	services to Medicaid recipients through a managed care plan, shall
7	provide the benefits required under this chapter to a Medicaid
8	recipient.
9	Sec. 1379.004. EXCEPTION. This chapter does not apply to:
10	(1) a plan that provides coverage:
11	(A) for wages or payments in lieu of wages for a
12	period during which an employee is absent from work because of
13	sickness or injury;
14	(B) as a supplement to a liability insurance
15	<pre>policy;</pre>
16	(C) for credit insurance;
17	(D) for a specified disease or diseases;
18	(E) only for dental or vision care;

- 7 SUBCHAPTER B. COVERAGE FOR ROUTINE PATIENT CARE COSTS
- 8 Sec. 1379.051. ROUTINE PATIENT CARE COSTS. For purposes of
- 9 this chapter, routine patient care costs means the costs of any
- 10 medically necessary health care service for which benefits are
- 11 provided under a health benefit plan, without regard to whether the
- 12 enrollee is participating in a clinical trial. Routine patient
- 13 care costs do not include:
- 14 (1) the cost of an investigational new drug or device
- 15 that is not approved for any indication by the United States Food
- 16 and Drug Administration, including a drug or device that is the
- 17 subject of the clinical trial;
- 18 (2) the cost of a service that is not a health care
- 19 service, regardless of whether the service is required in
- 20 connection with participation in a clinical trial;
- 21 (3) the cost of a service that is clearly inconsistent
- 22 with widely accepted and established standards of care for a
- 23 <u>particular diagnosis;</u>
- 24 (4) a cost associated with managing a clinical trial;
- 25 or
- 26 (5) the cost of a health care service that is
- 27 specifically excluded from coverage under a health benefit plan.

Sec. 1379.052. COVERAGE REQUIRED. A health benefit plan 1 2 issuer shall provide benefits for routine patient care costs to an 3 enrollee in connection with a phase I, phase II, phase III, or phase 4 IV clinical trial if the clinical trial is conducted in relation to the prevention, detection, or treatment of a life-threatening 5 6 disease or condition and is approved by: 7 (1) the Centers for Disease Control and Prevention of 8 the United States Department of Health and Human Services; 9 (2) the National Institutes of Health; the United States Food and Drug Administration; 10 (3) 11 (4)the United States Department of Defense; 12 (5) the United States Department of Veterans Affairs; 13 or 14 (6) an institutional review board of an institution in this state that has an agreement with the Office for Human Research 15 Protections of the United States Department of Health and Human 16 17 Services. Sec. 1379.053. RESEARCH INSTITUTION. (a) A health benefit 18 plan issuer is not required to reimburse the research institution 19 20 conducting the clinical trial for the cost of routine patient care provided through the research institution unless the research 21 institution, and each health care professional providing routine 22 patient care through the research institution, agrees to accept 23 reimbursement under the health benefit plan, at the rates that are 24 established under the plan, as payment in full for the routine 25 patient care provided in connection with the clinical trial. 26

(b) A health benefit plan issuer is not required to provide

- 1 benefits under this section for services that are a part of the
- 2 subject matter of the clinical trial and that are customarily paid
- 3 for by the research institution conducting the clinical trial.
- 4 Sec. 1379.054. LIMITATIONS ON COVERAGE.
- 5 (a) Notwithstanding Section 1379.053, this chapter does not
- 6 require a health benefit plan issuer to provide benefits for
- 7 routine patient care services provided outside of the plan's health
- 8 <u>care provider network unless out-of-network benefits are otherwise</u>
- 9 provided under the plan.
- 10 (b) This chapter does not require a health benefit plan
- 11 issuer to provide benefits for health care services provided
- 12 outside this state unless the health benefit plan otherwise
- 13 provides benefits for health care services provided outside this
- 14 state.
- 15 Sec. 1379.055. DEDUCTIBLE, COINSURANCE, AND COPAYMENT
- 16 REQUIREMENTS. The benefits required under this chapter may be made
- 17 <u>subject to a deductible, coinsurance, or copayment requirement</u>
- 18 comparable to other deductible, coinsurance, or copayment
- 19 requirements applicable under the health benefit plan.
- Sec. 1379.056. CANCELLATION OR NONRENEWAL PROHIBITED. The
- 21 issuer of a health benefit plan may not cancel or refuse to renew
- 22 coverage under a plan solely because an enrollee in the plan
- 23 participates in a clinical trial described by Section 1379.052.
- SECTION 2. Section 1506.151, Insurance Code, is amended by
- 25 adding Subsection (d) to read as follows:
- 26 (d) Coverage provided by the pool is subject to Chapter
- 27 1379.

- 1 SECTION 3. This Act applies only to a health benefit plan
- 2 that is delivered, issued for delivery, or renewed on or after
- 3 January 1, 2010. A health benefit plan that is delivered, issued
- 4 for delivery, or renewed before January 1, 2010, is governed by the
- 5 law as it existed immediately before the effective date of this Act,
- 6 and that law is continued in effect for that purpose.
- 7 SECTION 4. This Act takes effect September 1, 2009.
