Section 142.001, Education Code, is amended by 5 6 amending Subdivision (3) and adding Subdivision (3-a) to read as follows: 7 8 (3) "Eligible institution" means an institution of higher education [, as defined by Section 61.003(8) of this code]. 9 (3-a) "Institution of higher education" and "medical 10 and dental unit" have the meanings assigned by Section 61.003. 11 12 SECTION 2. Section 142.002, Education Code, is amended to 13 read as follows: 14 Sec. 142.002. PURPOSE. The advanced research program is 15 established to encourage and provide support for basic research conducted by faculty members and students in astronomy, atmospheric 16 17 science, biological and behavioral sciences, chemistry, computer sciences, earth sciences, engineering, information 18 science, mathematics, material sciences, oceanography, 19 physics, environmental issues affecting the Texas-Mexico border region, the 20 reduction of industrial, agricultural, and domestic water use, 21 22 social sciences, and related disciplines in eligible institutions. SECTION 3. Subsection (c), Section 142.003, Education Code, 23 24 is amended to read as follows:

1 (c) guidelines and procedures developed by the The 2 coordinating board must: 3 (1) provide for awards on a competitive, peer review 4 basis for specific projects at eligible institutions; and 5 (2) require that, as a condition of receiving an award, an eligible institution must use a portion of the award to 6 7 support, in connection with the project for which the award is made, basic research conducted by: 8 9 (A) graduate or undergraduate students, if the 10 eligible institution is a medical and dental unit; or (B) undergraduate students, if the eligible 11 institution is any other institution of higher education. 12 SECTION 4. This Act takes effect immediately if it receives 13 a vote of two-thirds of all the members elected to each house, as 14 provided by Section 39, Article III, Texas Constitution. If this 15 16 Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2009. 17
