4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 74, Education Code, is amended by adding
6	Subchapter N to read as follows:
7	SUBCHAPTER N. THE UNIVERSITY OF TEXAS HEALTH SCIENCE
8	CENTERSOUTH TEXAS
9	Sec. 74.751. HEALTH SCIENCE CENTER. (a) The board of
10	regents of The University of Texas System may operate The
11	University of Texas Health Science CenterSouth Texas as a
12	component institution of The University of Texas System with its
13	main campus and administrative offices in Cameron County. The

18 (b) The board of regents may include facilities located in Brooks, Cameron, Hidalgo, Jim Hogg, Kenedy, Kleberg, Starr, 19 20 Willacy, and Zapata Counties in the health science center and may

- Sec. 74.752. MEDICAL SCHOOL. If The University of Texas 23
- Health Science Center--South Texas is established under Section 24

- 1 74.751, The University of Texas Medical School--South Texas may be
- 2 established as a component of the health science center and as a
- 3 component institution of The University of Texas System under the
- 4 management and control of the board of regents of The University of
- 5 Texas System.
- 6 Sec. 74.753. PARTICIPATION IN AVAILABLE UNIVERSITY FUND.
- 7 In accordance with Section 18(c), Article VII, Texas Constitution,
- 8 <u>if the Act enacting this section receives a vote of two-thirds of</u>
- 9 all the members elected to each house of the legislature, and if an
- 10 institution is established under this subchapter, the institution
- 11 is entitled to participate in the funding provided by Section 18,
- 12 Article VII, Texas Constitution, for The University of Texas
- 13 System.
- 14 Sec. 74.754. COURSES AND DEGREES; RULES. The board of
- 15 regents may prescribe courses leading to customary degrees and may
- 16 adopt rules for the operation, control, and management of the
- 17 health science center as may be necessary for the conduct of a
- 18 medical school and other health science center programs of the
- 19 first class.
- Sec. 74.755. AFFILIATION AGREEMENTS; JOINT APPOINTMENTS.
- 21 (a) The board of regents may execute and carry out affiliation or
- 22 coordination agreements with any other entity or institution in the
- 23 <u>region.</u>
- 24 (b) The board of regents may make joint appointments in the
- 25 health science center, its component institutions, and other
- 26 <u>institutions under the board's governance. The salary of a person</u>
- 27 who receives a joint appointment shall be apportioned to the

- 1 appointing institutions on the basis of services rendered.
- 2 Sec. 74.756. GIFTS AND GRANTS; OTHER FUNDING. (a) The
- 3 board of regents may accept and administer gifts and grants from any
- 4 public or private person or entity for the use and benefit of the
- 5 health science center and its component institutions.
- 6 (b) Notwithstanding any other provision of this subchapter,
- 7 establishment of the health science center is subject to the
- 8 availability of funding, either through appropriation or from
- 9 another source.
- 10 Sec. 74.757. OTHER FACILITIES. In addition to the
- 11 facilities of the health science center and its component
- 12 institutions, the board of regents may enter into agreements under
- 13 which additional facilities used in the center's teaching and
- 14 research programs, including libraries, auditoriums, research
- 15 <u>facilities</u>, and medical education buildings, may be provided by a
- 16 public or private entity.
- Sec. 74.758. TEACHING HOSPITAL. A teaching hospital
- 18 considered suitable by the board of regents for the health science
- 19 <u>center may be provided by a public or private entity. The hospital</u>
- 20 may not be constructed, maintained, or operated with state funds.
- Sec. 74.759. COORDINATING BOARD SUPERVISION. The health
- 22 science center is subject to the continuing supervision of the
- 23 Texas Higher Education Coordinating Board under Chapter 61 and to
- 24 the rules of the coordinating board adopted under Chapter 61.
- Sec. 74.760. EFFECT OF HEALTH SCIENCE CENTER ON LOWER RIO
- 26 GRANDE VALLEY ACADEMIC HEALTH CENTER. (a) The board of regents
- 27 may convert the regional academic health center established under

- Subchapter L into The University of Texas Health Science 1 2 Center--South Texas and may establish The University of Texas Medical School--South Texas at the health science center as soon as 3 4 the board considers appropriate considering available resources and the best interests of The University of Texas System and the 5 people of this state and the South Texas region. In establishing 6 7 the health science center and medical school, the board of regents 8 shall ensure that the programs, students, and faculty and staff of 9 the regional academic health center are not affected other than as the board considers necessary to implement this subchapter. 10 (b) It is the intent of the legislature that The University
- 11 12 of Texas Health Science Center -- South Texas and its component 13 institutions be established by conversion of the regional academic health center established under Subchapter L and that those 14 entities be considered to be the same institution. A reference in 15 16 law to the regional academic health center applies to The University of Texas Health Science Center--South Texas to the 17 extent it can be made applicable. All contracts and agreements, 18 including bonds and other financial obligations, entered into by 19 20 The University of Texas System or any of its officers or employees relating to the regional academic health center apply to The 21 University of Texas Health Science Center--South Texas when the 22 23 health science center is established.
- (c) The permanent endowment fund established under Section

 25 63.101 for the benefit of the regional academic health center

 26 established under Subchapter L is transferred to the benefit of The

 27 University of Texas Health Science Center--South Texas and its

- 1 component institutions when the health science center is
- 2 established. It is the intent of the legislature that the transfer
- 3 of the permanent endowment fund be made so as not to interrupt the
- 4 research or other programs supported by distributions from the
- 5 fund.
- 6 SECTION 2. Section 55.1732, Education Code, is amended by
- 7 adding Subsection (e) to read as follows:
- 8 (e) Bonds authorized or issued under this section for the
- 9 regional academic health center established under Section 74.611
- 10 are considered to have been authorized or issued for The University
- 11 of Texas Health Science Center--South Texas and its component
- 12 institutions if the health science center is established.
- SECTION 3. Subdivision (5), Section 61.003, Education Code,
- 14 is amended to read as follows:

- 4 SECTION 5. Subsection (a), Section 65.02, Education Code,

- 6 SECTION 6. No funds for a state fiscal biennium ending on or
- 7 before August 31, 2015, may be appropriated for the purposes of
- 8 Subchapter N, Chapter 74, Education Code, as added by this Act.
- 9 SECTION 7. This Act does not make an appropriation. This
- 10 Act takes effect only if a specific appropriation for the
- 11 implementation of the Act is provided in a general appropriations
- 12 act of the 81st Legislature.
- SECTION 8. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2009.
