9	adopt standard insurance policy forms, printed endorsement forms,
10	and related forms other than insurance policy forms and printed
11	endorsement forms <u>.</u>
12	(b) The commissioner shall adopt standard insurance policy
13	forms, printed endorsement forms, and related forms other than
14	insurance policy forms and printed endorsement forms for use by an
15	insurer in writing residential property insurance.
16	(c) In [, that an insurer may use instead of the insurer's
17	<del>own forms in</del> ] writing insurance subject to this subchapter <u>other</u>
18	than residential property insurance, an insurer may use the
19	standard forms adopted by the commissioner under Subsection (a)
20	instead of the insurer's own forms. In writing residential
21	property insurance, an insurer shall use the standard forms in the
22	manner prescribed by Section 2301.0525.

1 (b) <u>Subject to Section 2301.0525, an</u> [An] insurer may 2 continue to use an insurance policy form or endorsement 3 promulgated, approved, or adopted under Article 5.06 or 5.35 before 4 June 11, 2003, on written notification to the commissioner that the 5 insurer will continue to use the form or endorsement.

SECTION 3. Subchapter B, Chapter 2301, Insurance Code, is

7 amended by adding Section 2301.0525 to read as follows:

8 <u>Sec. 2301.0525. USE OF CERTAIN STANDARD INSURANCE POLICY</u> 9 <u>FORMS REQUIRED. (a) Each insurer that writes residential property</u> 10 <u>insurance in this state shall use the standard insurance policy</u> 11 <u>forms adopted by the commissioner under Section 2301.008 for</u> 12 <u>residential property insurance and, subject to Subsection (b), may</u> 13 <u>also use alternative policy forms approved by the commissioner</u> 14 under Section 2301.006.

15 (b) An insurer may not deliver or issue for delivery in this state a residential property insurance policy unless the insurer 16 17 informs all applicants for that insurance coverage, in the manner prescribed by commissioner rule, that an applicant otherwise 18 qualified for that insurance coverage under this code may elect to 19 obtain residential property insurance coverage under a standard 20 21 insurance policy adopted by the commissioner under Section 22 2301.008.

SECTION 4. This Act applies only to an insurance policy delivered, issued for delivery, or renewed on or after January 1, 2010. A policy delivered, issued for delivery, or renewed before January 1, 2010, is governed by the law as it existed immediately before the effective date of this Act, and that law is continued in

effect for that purpose.
SECTION 5. This Act takes effect September 1, 2009.
