The board may propose rules establishing minimum standards for approval or 10 renewal of approval of: 11 (1) educator preparation programs; or 12 13 (2) certification fields authorized to be offered by 14 an educator preparation program. Sec. 21.0451. SANCTIONS UNDER ACCOUNTABILITY SYSTEM FOR 15 16 EDUCATOR PREPARATION PROGRAMS.
