4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter I, Chapter 2166, Government Code, is
6	amended by adding Section 2166.409 to read as follows:
7	Sec. 2166.409. HIGH-PERFORMANCE, SUSTAINABLE DESIGN,
8	CONSTRUCTION, AND RENOVATION STANDARDS FOR STATE BUILDINGS.
9	(a) This section applies to the construction of a state building,
10	or the renovation of a state building the cost of which is more than
11	50 percent of the value of the building, including a building for
12	education, assembly, or office occupancy under the charge and
13	control of the Texas Department of Transportation, the Parks and
14	Wildlife Department, the Texas Department of Housing and Community
15	Affairs, the Texas State Affordable Housing Corporation, or the
16	Veterans' Land Board that is otherwise exempt from this chapter
17	under Section 2166.003.
18	(b) A building to which this section applies must be
19	designed and constructed or renovated so that the building achieves

- certification under a high-performance building standard that: 20
- 21 (1) is developed and revised through a consensus-based
- 22 process;
- 23 (2) provides minimum requirements for energy use,
- 24 natural resources use, and indoor air quality;

- 1 (3) requires substantiating documentation for
- 2 certification;
- 3 (4) employs third-party, post-construction review and
- 4 verification for certification; and
- 5 (5) is determined by the state energy conservation
- 6 office to be nationally recognized in the building industry.
- 7 (c) A contract between the commission and a private design
- 8 professional relating to services in connection with the
- 9 construction or renovation of a building to which this section
- 10 applies must provide that, for billing purposes, any service
- 11 provided by the private design professional that is necessary to
- 12 satisfy the requirements of Subsection (b) is considered an
- additional service rather than a basic service.
- 14 SECTION 2. Subchapter B, Chapter 55, Education Code, is
- amended by adding Section 55.115 to read as follows:
- 16 Sec. 55.115. HIGH-PERFORMANCE, SUSTAINABLE DESIGN,
- 17 CONSTRUCTION, AND RENOVATION STANDARDS FOR CERTAIN FACILITIES.
- 18 (a) This section applies to the construction of an institution of
- 19 higher education building, structure, or other facility, or the
- 20 renovation of a building, structure, or other facility the cost of
- 21 which is more than 50 percent of the value of the building,
- 22 structure, or other facility, any part of the construction or
- 23 renovation of which is financed by revenue bonds issued under this
- subchapter.
- 25 (b) A building, structure, or other facility to which this
- 26 section applies must be designed and constructed or renovated so
- 27 that the building, structure, or other facility achieves

- 1 certification under a high-performance building standard that:
- 2 (1) is developed and revised through a consensus-based
- 3 process;
- 4 (2) provides minimum requirements for energy use,
- 5 natural resources use, and indoor air quality;
- 6 (3) requires substantiating documentation for
- 7 <u>certification;</u>
- 8 (4) employs third-party, post-construction review and
- 9 verification for certification; and
- 10 <u>(5) is determined by the state energy conservation</u>
- office to be nationally recognized in the building industry.
- 12 (c) A contract between an institution of higher education
- and a private design professional, as defined by Section 2166.001,
- 14 Government Code, relating to services in connection with the
- 15 construction or renovation of a building, structure, or other
- 16 <u>facility to which this section applies must provide that, for</u>
- 17 billing purposes, any service provided by the private design
- 18 professional that is necessary to satisfy the requirements of
- 19 Subsection (b) is considered an additional service rather than a
- 20 basic service.
- 21 SECTION 3. Section 55.115, Education Code, and Section
- 22 2166.409, Government Code, as added by this Act, apply only to an
- 23 institution of higher education building, structure, or other
- 24 facility or a state building for which the contract for design
- 25 services is entered into on or after September 1, 2011.
- 26 SECTION 4. This Act takes effect September 1, 2009.
