A BILL TO BE ENTITLED

AN ACT 1 2 relating to a health passport for Medicaid recipients. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Subchapter B, Chapter 531, Government Code, is amended by adding Section 531.096 to read as follows: 5 Sec. 531.096. HEALTH PASSPORT. (a) The commission, with 6 the assistance of physicians and other health care providers 7 experienced with the use of electronic health records, shall 8 9 develop and provide a health passport for each person who: (1) is receiving medical assistance under the state 10 11 Medicaid program through a managed care plan, as defined by Section 12 533.001; and (2) is not provided a health passport under another 13 14 law of this state. 15 (a-1) Notwithstanding Subsection (a), the commission is not

required to provide a health passport for each person described by that subsection until September 1, 2014. Beginning as soon as feasible after September 1, 2009, the commission shall provide a health passport to each child entitled to a health passport under Subsection (a), or if initial provision of health passports to all 20 children is impossible, to selected categories of children. Thereafter, at intervals occurring as soon as possible, the commission shall expand the provision of health passports to additional children and finally to adults. This subsection expires

- 2 (b) Information that is accessible through the health
- 3 passport provided under this section must be maintained in an
- 4 electronic format that uses the commission's existing computer
- 5 resources to the greatest extent possible.
- 6 (c) The executive commissioner shall adopt rules specifying
- 7 the information required to be included in the health passport. The
- 8 required information may include:
- 9 (1) the name and address of each of the person's
- 10 physicians and health care providers;
- 11 (2) a record of each visit to a physician or other
- 12 health care provider, including routine checkups;
- 13 (3) an immunization record;
- 14 (4) a list of the person's known health problems and
- 15 <u>allergies;</u>
- 16 (5) information on all medications prescribed to the

- 22 (d) The system used to access the health passport must be
- 23 <u>secure and maintain the confidentiality</u> of the person's health

- 1 Accountability Act of 1996 (Pub. L. No. 104-191) contained in 45
- 2 C.F.R. Part 160 and 45 C.F.R. Part 164, Subparts A and E, the
- 3 covered entity shall ensure that the use or disclosure complies
- 4 with all applicable requirements, standards, or implementation
- 5 specifications of the privacy rule.
- 6 (e) The commission shall provide training or instructional
- 7 <u>materials regarding use of a health passport to adults who receive</u>
- 8 health passports, parents, guardians, and caretakers of children
- 9 who receive health passports, physicians, and other health care
- 10 providers.
- 11 (f) The commission shall make health passport information
- 12 available in printed and electronic formats to the following
- individuals when a person loses eligibility for Medicaid, unless
- 14 the commission is required to provide a health passport under
- 15 <u>another program:</u>
- 16 <u>(1) the person, if the person is an adult or a child</u>
- 17 who has had the disabilities of minority removed; or
- 18 (2) the person's parent, legal guardian, or other
- 19 caretaker, if the person is a child.
- 20 (g) The commission shall coordinate the health passports
- 21 and procedures adopted for the Medicaid program under this section
- 22 with the health passport and procedures adopted under Section
- 23 <u>266.006</u>, Family Code, for a child in the foster care system to
- 24 ensure that a child's health passport is transferable between the
- 25 Medicaid program and that system.
- SECTION 2. Section 32.102(b), Human Resources Code, as
- 27 added by Chapter 268 (S.B. 10), Acts of the 80th Legislature,

- 1 Regular Session, 2007, is amended to read as follows:
- 2 (b) If the executive commissioner determines that a need
- 3 exists for the use of health information technology in the medical
- 4 assistance program and that the technology is cost-effective, the
- 5 Health and Human Services Commission may, for the purposes
- 6 prescribed by Subsection (a):
- 7 (1) acquire and implement the technology; or
- 8 (2) evaluate the feasibility of developing and, if
- 9 feasible, develop, the technology through the use or expansion of
- 10 other systems or technologies the commission uses for other
- 11 purposes, including:
- 12 (A) the technologies used in the pilot program
- implemented under Section 531.1063, Government Code; and
- 14 (B) a [the] health passport developed under
- 15 Section 266.006, Family Code, or Section 531.096, Government Code,
- 16 for persons receiving medical assistance not provided a health
- 17 passport under either of those provisions.
- 18 SECTION 3. If before implementing any provision of this Act
- 19 a state agency determines that a waiver or authorization from a
- 20 federal agency is necessary for implementation of that provision,
- 21 the agency affected by the provision shall request the waiver or
- 22 authorization and may delay implementing that provision until the
- 23 waiver or authorization is granted.
- 24 SECTION 4. Except as otherwise provided by this Act, this
- 25 Act takes effect September 1, 2009.
