## A BILL TO BE ENTITLED

4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 61, Education Code, is amended by adding
6	Subchapter HH to read as follows:
7	SUBCHAPTER HH. HEALTH PROFESSIONAL EDUCATION GRANT PROGRAM
8	Sec. 61.9801. DEFINITION. In this subchapter, "eligible
9	health professional education program" means:
10	(1) an accredited physician residency training
11	<pre>program;</pre>
12	(2) an accredited professional nursing program that
13	prepares students for initial licensure as registered nurses;
14	(3) an accredited vocational nursing program that
15	prepares students for licensure as licensed vocational nurses;
16	(4) an accredited advanced nurse practitioner program
17	leading to registration with the Board of Nurse Examiners as an
18	advanced nurse practitioner;
19	(5) an undergraduate or graduate physician assistant
20	program accredited by the Accreditation Review Commission or
21	Education for the Physician Assistant or its successor; or
22	(6) an accredited undergraduate or graduate allied
23	health program that prepares students to practice as allied health

professionals, as defined by 42 U.S.C. Section 295p.

- 1 Sec. 61.9802. HEALTH PROFESSIONAL EDUCATION GRANTS;
- 2 PURPOSE. (a) The board may award health professional education
- 3 grants to eligible health professional education programs at
- 4 institutions of higher education to:
- 5 (1) assist the programs in:
- 6 (A) providing new distance learning or
- 7 <u>community-based education projects or activities; or</u>
- 8 <u>(B) expanding or enhancing existing distance</u>

- 11 (b) The board may not award a grant under this section to

- Sec. 61.9803. <u>USE OF GRANT</u>. A grant awarded under this
- 15 subchapter may be used only for a purpose described by Section
- 16 61.9802.
- Sec. 61.9804. ADVISORY COMMITTEE. The board may appoint an
- 18 advisory committee to advise the board on successful strategies for
- 19 assisting eligible health professional education programs in
- 20 providing, expanding, or enhancing distance learning or
- 21 community-based education projects or activities.
- Sec. 61.9805. ANNUAL REPORTS. (a) At the end of each
- 23 <u>academic year for which an eligible health professional education</u>
- 24 program is awarded a grant under this subchapter and in the form the
- 25 board requires, the program shall provide to the board a written
- 26 report regarding the use of the grant.
- (b) Not later than October 31 of each year, the board shall

- 2 consolidated from the reports submitted to the board under
- 3 <u>Subsection (a).</u>
- 4 SECTION 2. Beginning with the 2010-2011 academic year, the
- 5 Texas Higher Education Coordinating Board shall award grants under
- 6 the health professional education grant program created under
- 7 Subchapter HH, Chapter 61, Education Code, as added by this Act.
- 8 SECTION 3. This Act takes effect September 1, 2009.
