1 AN ACT 2 relating to certain civil consequences of engaging in organized 3 crime. Δ BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Subdivision (2), Article 59.01, Code of Criminal 5 6 Procedure, as amended by Chapters 127 (S.B. 1694), 822 (H.B. 73), and 885 (H.B. 2278), Acts of the 80th Legislature, Regular Session, 7 2007, is amended to read as follows: 8 (2) "Contraband" means property of 9 any nature, 10 including real, personal, tangible, or intangible, that is: (A) used in the commission of: 11 12 (i) any first or second degree felony under 13 the Penal Code; 14 (ii) any felony under Section 15.031(b), 15 20.05, 21.11, 38.04, Subchapter B of Chapter 43, or Chapter 29, 30, 31, 32, 33, 33A, or 35, Penal Code; 16 (iii) any felony under The Securities Act 17 (Article 581-1 et seq., Vernon's Texas Civil Statutes); or 18 19 (iv) any offense under Chapter 49, Penal Code, that is punishable as a felony of the third degree or state 20 jail felony, if the defendant has been previously convicted three 21 22 times of an offense under that chapter; 23 (B) used or intended to be used in the commission 24 of:

SECTION 2. Chapter 59, Code of Criminal Procedure, is
amended by adding Article 59.011 to read as follows:

9 <u>Art. 59.011. PROPERTY USED FOR ORGANIZED CRIMINAL ACTIVITY.</u> 10 <u>If property described by Article 59.01(2)(B)(x) is subject to</u> 11 <u>forfeiture under this chapter and Article 18.18, the attorney</u> 12 <u>representing the state may proceed under either provision.</u>

13 SECTION 3. The change in law made by this Act applies only to the forfeiture of property used in the commission of an offense 14 15 committed on or after the effective date of this Act. Forfeiture of 16 property used in the commission of an offense committed before the effective date of this Act is governed by the law in effect when the 17 offense was committed, and the former law is continued in effect for 18 For purposes of this section, an offense was 19 that purpose. committed before the effective date of this Act if any element of 20 the offense occurred before that date. 21

SECTION 4. This Act takes effect September 1, 2009.
