- 1 AN ACT
- 2 relating to an intercollegiate athletics fee at the University of
- 3 North Texas.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter E, Chapter 54, Education Code, is
- 6 amended by adding Section 54.5191 to read as follows:
- 7 Sec. 54.5191. INTERCOLLEGIATE ATHLETICS FEE; UNIVERSITY OF
- 8 NORTH TEXAS. (a) The board of regents of the University of North
- 9 Texas System may charge each student enrolled at the University of
- 10 North Texas an intercollegiate athletics fee in an amount not to
- 11 exceed \$10 per semester credit hour for each semester or summer
- 12 session.
- 13 (b) A student enrolled in more than 15 semester credit hours
- 14 shall pay the fee in an amount equal to the amount imposed on a
- 15 student enrolled in 15 semester credit hours during the same
- 16 semester or session.
- 17 (c) The fee may not be charged before the first semester a
- 18 new football stadium is available for use at the university.
- 19 <u>(d) If compulsory student services fees are charged to</u>
- 20 students enrolled at the university under Section 54.503, the total
- 21 amount of those fees charged to a student shall be reduced by \$3 per
- 22 semester credit hour for the first semester in which an
- 23 intercollegiate athletics fee is charged under this section.
- (e) Revenue from the fee charged under this section may be

- 1 used only for financing, constructing, operating, maintaining, or
- 2 improving an athletic facility or for operating an intercollegiate
- 3 athletics program at the university.
- 4 (f) The fee may not be charged unless approved by a majority
- 5 vote of the students enrolled at the university who participate in a
- 6 general student election held for that purpose. The ballot for the
- 7 election to approve the fee must state a maximum amount of the fee
- 8 that may be charged per semester credit hour, not to exceed the
- 9 maximum amount prescribed by Subsection (a).
- 10 (g) The amount of the fee may not be increased to an amount
- 11 that exceeds by 10 percent or more the amount of the fee as last
- 12 approved by a student vote under Subsection (f) or this subsection
- 13 unless the increase has been approved by a majority vote of the
- 14 students enrolled at the university who participate in a general
- 15 student election held for that purpose.
- 16 (h) The chief fiscal officer of the university shall collect
- 17 the fee and shall deposit the revenue from the fee in an account to
- 18 be known as the intercollegiate athletics fee account.
- 19 (i) A fee charged under this section is not considered in
- 20 determining the maximum amount of student services fees that may be
- 21 charged each student enrolled at the university under Section
- 22 54.503.
- 23 (j) The fee may not be charged after the fifth academic year
- 24 in which the fee is first charged unless, before the end of that
- 25 academic year, the university has issued bonds payable from the
- 26 fee, in which event the fee may not be charged after the academic
- 27 year in which all such bonds, including refunding bonds for those

1	bonds, have been fully paid.
2	SECTION 2. This Act takes effect immediately if it receives
3	a vote of two-thirds of all the members elected to each house, as
4	provided by Section 39, Article III, Texas Constitution. If this
5	Act does not receive the vote necessary for immediate effect, this
5	Act takes effect September 1, 2009.
