A BILL TO BE ENTITLED

1	AN ACT
2	relating to the operation of a motor vehicle in the vicinity of a
3	vulnerable road user; providing penalties.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 545, Transportation Code,
6	is amended by adding Section 545.428 to read as follows:
7	Sec. 545.428. VULNERABLE ROAD USERS. (a) In this section,
8	"vulnerable road user" means:
9	(1) a pedestrian, including a runner, physically
10	disabled person, child, skater, highway construction and
11	maintenance worker, utility worker, other worker with legitimate
12	business in or near the road or right of way, or stranded motorist
13	or passenger;
14	(2) a person on horseback; or
15	(3) a person operating equipment other than a motor
16	vehicle, including a bicycle, motorcycle, horse-driven conveyance,
17	or unprotected farm equipment.
18	(b) An operator of a motor vehicle passing a vulnerable road
19	user operating on a highway or street shall:
20	(1) vacate the lane in which the vulnerable road user
21	is located if the highway has two or more marked lanes running ir
22	the same direction; or
23	(2) pass the vulnerable road user at a safe distance.
24	(c) For the purposes of Subsection (b)(2), the operator is

- 1 presumed to have passed the vulnerable road user at a safe distance
- 2 if the distance between the operator's vehicle and the vulnerable
- 3 road user is more than:
- 4 (1) three feet if the operator's vehicle is a passenger
- 5 car or light truck; or
- 6 (2) six feet if the operator's vehicle is a truck other
- 7 than a light truck or a commercial motor vehicle as defined by
- 8 <u>Section 522.003.</u>
- 9 (d) An operator of a motor vehicle that is making a left turn
- 10 at an intersection, including an intersection with an alley or
- 11 private road or driveway, shall yield the right-of-way to a
- 12 vulnerable road user who is approaching from the opposite direction
- and is in the intersection or in such proximity to the intersection
- 14 as to be an immediate hazard.
- (e) An operator of a motor vehicle may not overtake a
- 16 vulnerable road user traveling in the same direction and
- 17 subsequently make a right-hand turn in front of the vulnerable road
- 18 user unless the operator is safely clear of the vulnerable road
- 19 user, taking into account the speed at which the vulnerable road
- 20 user is traveling and the braking requirements of the vehicle
- 21 making the right-hand turn.
- 22 <u>(f) An operator of a motor vehicle may not maneuver the</u>
- 23 vehicle in a manner that:
- 24 (1) is intended to cause intimidation or harassment to
- 25 a vulnerable road user; or
- 26 (2) threatens a vulnerable road user.
- 27 (g) An operator of a motor vehicle shall exercise due care

- 1 to avoid colliding with any vulnerable road user on a roadway or in
- 2 an intersection of roadways.
- 3 (h) A person may not open the door on the side of a vehicle
- 4 that is adjacent to moving traffic unless it is reasonably safe to
- 5 open the door without interfering with the movement of traffic,
- 6 including vulnerable road users. A person may not leave a door open
- 7 on the side of a vehicle that is adjacent to moving traffic for a
- 8 period longer than necessary to load or unload passengers or goods.
- 9 (i) A person may not harass, taunt, or throw an object or
- 10 liquid at or in the direction of any vulnerable road user.
- 11 (j) A violation of this section is punishable under Section
- 12 542.401 except that:
- 13 (1) if the violation results in property damage, the
- 14 violation is a misdemeanor punishable by a fine of not to exceed
- 15 <u>\$500; or</u>
- 16 (2) if the violation results in bodily injury, the
- violation is a Class B misdemeanor.
- 18 (k) It is a defense to prosecution under this section that
- 19 at the time of the offense the vulnerable road user was a person
- 20 operating a bicycle in violation of Section 551.103 or
- 21 <u>551.104(b)(2).</u>
- 22 (1) If conduct constituting an offense under this section
- 23 also constitutes an offense under another section of this code or
- the Penal Code, the actor may be prosecuted under either section or
- 25 both sections.
- 26 SECTION 2. This Act takes effect September 1, 2009.
