A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the employment of certified counselors by school
- 3 districts.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subsections (b) and (c), Section 33.002,
- 6 Education Code, are amended to read as follows:
- 7 (b) A school district with 350 [500] or more students in
- 8 <u>enrollment</u> [enrolled in elementary school grades] shall employ a
- 9 counselor certified under the rules of the State Board for Educator
- 10 Certification for each [elementary] school in the district. A
- 11 school district shall employ at least one counselor for every 350
- 12 [500 elementary school] students in the district.
- (c) A school district with fewer than 350 [500] students in
- 14 enrollment [enrolled in elementary school grades] shall provide
- 15 guidance and counseling services to [elementary school] students
- 16 by:
- 17 (1) employing a part-time counselor certified under
- 18 the rules of the State Board for Educator Certification;
- 19 (2) employing a part-time teacher certified as a
- 20 counselor under the rules of the State Board for Educator
- 21 Certification; or
- 22 (3) entering into a shared services arrangement
- 23 agreement with one or more school districts to share a counselor
- 24 certified under the rules of the State Board for Educator

- 1 Certification.
- 2 SECTION 2. Subsection (i), Section 42.152, Education Code,
- 3 is amended to read as follows:
- 4 (i) From the total amount of funds appropriated for
- 5 allotments under this section, the commissioner shall, each fiscal
- 6 year, withhold \$7,500,000 or a greater amount as determined in the
- 7 General Appropriations Act and distribute that amount for programs
- 8 under Subchapter A, Chapter 33. Funds distributed under this
- 9 <u>subsection are in addition to any other funds available for</u>
- 10 programs under Subchapter A, Chapter 33, including funds provided
- 11 under Section 42.2518 [A program established under that subchapter
- 12 is required only in school districts in which the program is
- 13 financed by funds distributed under this section or other funds
- 14 distributed by the commissioner for a program under that
- 15 subchapter. In distributing those funds, preference shall be given
- 16 to a school district that received funds for a program under this
- 17 subsection for the preceding school year].
- 18 SECTION 3. Subchapter E, Chapter 42, Education Code, is
- 19 amended by adding Section 42.2518 to read as follows:
- 20 Sec. 42.2518. ADDITIONAL STATE AID FOR CERTIFIED
- 21 COUNSELORS. (a) For each school year, from funds that may be used
- 22 for the purpose, a school district is entitled to state aid in an
- 23 <u>amount, as determined by the commissioner, sufficient to assist the</u>
- 24 district in employing the number of certified counselors required
- 25 by Section 33.002.
- 26 (b) The commissioner shall adopt rules as necessary to
- 27 administer this section.

- 1 SECTION 4. Subsection (a), Section 33.002, Education Code,
- 2 is repealed.
- 3 SECTION 5. This Act applies beginning with the 2009-2010
- 4 school year.
- 5 SECTION 6. This Act takes effect September 1, 2009.
