A BILL TO BE ENTITLED 1 AN ACT 2 relating to the creation of the Caldwell County Municipal Utility District No. 1; providing authority to impose a tax and issue bonds; 3 granting a limited power of eminent domain. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Subtitle F, Title 6, Special District Local Laws 6 7 Code, is amended by adding Chapter 8307 to read as follows: CHAPTER 8307. CALDWELL COUNTY MUNICIPAL UTILITY DISTRICT No. 1 8 9 SUBCHAPTER A. GENERAL PROVISIONS Sec. 8307.001. DEFINITIONS. In this chapter: 10 (1) "Board" means the district's board of directors. 11 12 (2) "Director" means a board member. 13 (3) "District" means the Caldwell County Municipal 14 Utility District No. 1. Sec. 8307.002. NATURE OF DISTRICT. The district is a 15 16 municipal utility district created under Section 59, Article XVI, 17 Texas Constitution. Sec. 8307.003. CONFIRMATION AND DIRECTORS' ELECTION 18 19 REQUIRED. The temporary directors shall hold an election to confirm the creation of the district and to elect five permanent 20 directors as provided by Section 49.102, Water Code. 21 Sec. 8307.004. CONSENT OF MUNICIPALITY REQUIRED. 22 The 23 temporary directors may not hold an election under Section 8307.003 until each municipality in whose corporate limits or 24

extraterritorial jurisdiction the district is located 1 has the 2 consented by ordinance or resolution to the creation of 3 district and to the inclusion of land in the district. 4 Sec. 8307.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a) 5 The district is created to serve a public purpose and benefit. 6 (b) The district is created to accomplish the purposes of: 7 (1) a municipal utility district as provided by general law and Section 59, Article XVI, Texas Constitution; and 8 (2) Section 52, Article III, Texas Constitution, that 9 relate to the construction, acquisition, improvement, operation, 10 or maintenance of macadamized, graveled, or paved roads, or 11 12 improvements, including storm drainage, in aid of those roads. Sec. 8307.006. INITIAL DISTRICT TERRITORY. (a) The 13 14 district is initially composed of the territory described by 15 Section 2 of the Act creating this chapter. 16 (b) The boundaries and field notes contained in Section 2 of 17 the Act creating this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative process 18 19 does not affect the district's: (1) organization, existence, or validity; 20 21 (2) right to issue any type of bond for the purposes 22 for which the district is created or to pay the principal of and 23 interest on a bond; 24 (3) right to impose a tax; or 25 (4) legality or operation. 26 [Sections 8307.007-8307.050 reserved for expansion]

27	(d) If Subsection (c) applies, the owner or owners of a

1 majority of the assessed value of the real property in the district may submit a petition to the commission requesting that the 2 commission appoint as successor temporary directors the five 3 persons named in the petition. The commission shall appoint as 4 5 successor temporary directors the five persons named in the 6 petition. 7 [Sections 8307.053-8307.100 reserved for expansion] 8 SUBCHAPTER C. POWERS AND DUTIES Sec. 8307.101. GENERAL POWERS AND DUTIES. The district has 9 10 the powers and duties necessary to accomplish the purposes for which the district is created. 11 12 Sec. 8307.102. MUNICIPAL UTILITY DISTRICT POWERS AND DUTIES. The district has the powers and duties provided by the 13 general law of this state, including Chapters 49 and 54, Water Code, 14 applicable to municipal utility districts created under Section 59, 15 Article XVI, Texas Constitution. 16 17 Sec. 8307.103. AUTHORITY FOR ROAD PROJECTS. Under Section 52, Article III, Texas Constitution, the district may design, 18 acquire, construct, finance, issue bonds for, improve, operate, 19 maintain, and convey to this state, a county, or a municipality for 20 operation and maintenance macadamized, graveled, or paved roads, or 21 22 improvements, including storm drainage, in aid of those roads. Sec. 8307.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road 23 24 project must meet all applicable construction standards, zoning and subdivision requirements, and regulations of each municipality in 25 26 whose corporate limits or extraterritorial jurisdiction the road 27 project is located.

No. 660 1 (b) If a road project is not located in the corporate limits 2 or extraterritorial jurisdiction of a municipality, the road project must meet all applicable construction standards, 3 subdivision requirements, and regulations of each county in which 4 5 the road project is located. (c) If the state will maintain and operate the road, the 6 7 Texas Transportation Commission must approve the plans and 8 specifications of the road project. 9 Sec. 8307.105. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE OR RESOLUTION. The district shall comply with all applicable 10 requirements of any ordinance or resolution that is adopted under 11 12 Section 54.016 or 54.0165, Water Code, and that consents to the creation of the district or to the inclusion of land in the 13 14 district. Sec. 8307.106. LIMITATION ON USE OF EMINENT DOMAIN. 15 The district may not exercise the power of eminent domain outside the 16 17 district to acquire a site or easement for: 18 (1) a road project authorized by Section 8307.103; or 19 (2) a recreational facility as defined by Section 49.462, Water Code. 20 21 Sec. 8307.107. DIVISION OF DISTRICT. (a) The district may 22 be divided into two or more new districts only if the district: 23 (1) has no outstanding bonded debt; and 24 (2) is not imposing ad valorem taxes. (b) This chapter applies to any new district created by the 25 26 division of the district, and a new district has all the powers and 27 duties of the district.

No. 660 1 (c) Any new district created by the division of the district may not, at the time the new district is created: 2 (1) contain any land outside the area described by 3 Section 2 of the Act creating this chapter; or 4 5 (2) contain less than 100 acres. 6 (d) The board, on its own motion or on receipt of a petition 7 signed by the owner or owners of a majority of the assessed value of 8 the real property in the district according to the most recent certified appraisal roll for each county in which the district is 9 located, may adopt an order dividing the district. 10 (e) The board may adopt an order dividing the district 11 12 before or after the date the board holds an election under Section 8307.003 to confirm the district's creation. 13 14 (f) An order dividing the district shall: 15 (1) name each new district; 16 (2) include the metes and bounds description of the 17 territory of each new district; (3) appoint temporary directors for each new district; 18 19 and (4) provide for the division of assets and liabilities 20 between or among the new districts. 21 (g) On or before the 30th day after the date of adoption of 22 an order dividing the district, the district shall file the order 23 24 with the Texas Commission on Environmental Quality and record the order in the real property records of each county in which the 25 26 district is located. (h) Any new district created by the division of the district 27

15	(2) contract payments described by Section 8307.153.
16	(b) The district must hold an election in the manner
17	provided by Chapters 49 and 54, Water Code, to obtain voter approval
18	before the district may impose an ad valorem tax or issue bonds
19	payable from ad valorem taxes.
20	(c) The district may not issue bonds payable from ad valorem
21	taxes to finance a road project unless the issuance is approved by a
22	vote of a two-thirds majority of the district voters voting at an
23	election held for that purpose.
24	Sec. 8307.152. OPERATION AND MAINTENANCE TAX. (a) If
25	authorized at an election held under Section 8307.151, the district
26	may impose an operation and maintenance tax on taxable property in
27	the district in accordance with Section 49.107, Water Code.

1 (b) The board shall determine the tax rate. The rate may not 2 exceed the rate approved at the election. Sec. 8307.153. CONTRACT TAXES. (a) In accordance with 3 Section 49.108, Water Code, the district may impose a tax other than 4 5 an operation and maintenance tax and use the revenue derived from the tax to make payments under a contract after the provisions of 6 7 the contract have been approved by a majority of the district voters 8 voting at an election held for that purpose. 9 (b) A contract approved by the district voters may contain a 10 provision stating that the contract may be modified or amended by 11 the board without further voter approval. 12 [Sections 8307.154-8307.200 reserved for expansion]

14 <u>Sec. 8307.201. AUTHORITY TO ISSUE BONDS AND OTHER</u> 15 <u>OBLIGATIONS. The district may issue bonds or other obligations</u> 16 <u>payable wholly or partly from ad valorem taxes, impact fees,</u> 17 <u>revenue, contract payments, grants, or other district money, or any</u> 18 <u>combination of those sources, to pay for any authorized district</u> 19 <u>purpose.</u>

20 <u>Sec. 8307.202. TAXES FOR BONDS. At the time the district</u> 21 <u>issues bonds payable wholly or partly from ad valorem taxes, the</u> 22 <u>board shall provide for the annual imposition of a continuing</u> 23 <u>direct ad valorem tax, without limit as to rate or amount, while all</u> 24 <u>or part of the bonds are outstanding as required and in the manner</u> 25 <u>provided by Sections 54.601 and 54.602, Water Code.</u>

26 <u>Sec. 8307.203. BONDS FOR ROAD PROJECTS. At the time of</u> 27 <u>issuance, the total principal amount of bonds or other obligations</u>

<u>issued or incurred to finance road projects and payable from ad</u>
 <u>valorem taxes may not exceed one-fourth of the assessed value of the</u>

3 real property in the district.

1 introduce this Act, setting forth the general substance of this
2 Act, has been published as provided by law, and the notice and a
3 copy of this Act have been furnished to all persons, agencies,
4 officials, or entities to which they are required to be furnished
