- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Article 12.01, Code of Criminal Procedure, as
- 6 amended by Chapters 285 (H.B. 716), 593 (H.B. 8), 640 (H.B. 887),
- 7 and 841 (H.B. 959), Acts of the 80th Legislature, Regular Session,
- 8 2007, is reenacted and amended to read as follows:
- 9 Art. 12.01. FELONIES. Except as provided in Article 12.03,
- 10 felony indictments may be presented within these limits, and not
- 11 afterward:

- 14 (B) sexual assault under Section 22.011(a)(2),
- 15 Penal Code, or aggravated sexual assault under Section

- 18 of the offense biological matter is collected and subjected to
- 19 forensic DNA testing and the testing results show that the matter

- 24 (E) indecency with a child under Section 21.11,

- 25 SECTION 2. The change in law made by this Act does not apply
- 26 to an offense if the prosecution of that offense becomes barred by
- 27 limitation before the effective date of this Act. The prosecution

- 1 of that offense remains barred as if this Act had not taken effect.
- 2 SECTION 3. To the extent of any conflict, this Act prevails
- 3 over another Act of the 81st Legislature, Regular Session, 2009,
- 4 relating to nonsubstantive additions to and corrections in enacted
- 5 codes.
- 6 SECTION 4. This Act takes effect September 1, 2009.
