9	SUBCHAPTER A. GENERAL PROVISIONS	
10	Sec. 8337.001. DEFINITIONS. In this chapter:	
11	(1) "Board" means the district's board of directors.	
12	(2) "Director" means a board member.	
13	(3) "District" means the Fort Bend County Municipal	
14	Utility District No. 200.	
15	Sec. 8337.002. NATURE OF DISTRICT. The district is a	
16	municipal utility district created under Section 59, Article XVI,	
17	Texas Constitution.	
18	Sec. 8337.003. CONFIRMATION AND DIRECTORS' ELECTION	
19	REQUIRED. The temporary directors shall hold an election to	
20	confirm the creation of the district and to elect five permanent	
21	directors as provided by Section 49.102, Water Code.	
22	Sec. 8337.004. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.	
23	(a) The district is created to serve a public purpose and benefit.	
24	(b) The district is created to accomplish the purposes of:	

1 (1) a municipal utility district as provided by 2 general law and Section 59, Article XVI, Texas Constitution; and 3 (2) Section 52, Article III, Texas Constitution, that relate to the construction, acquisition, or improvement of 4 macadamized, graveled, or paved roads described by Section 54.234, 5 Water Code, or improvements, including storm drainage, in aid of 6 7 those roads. Sec. 8337.005. INITIAL DISTRICT TERRITORY. (a) The 8 district is initially composed of the territory described by 9 Section 2 of the Act creating this chapter. 10 11 (b) The boundaries and field notes contained in Section 2 of 12 the Act creating this chapter form a closure. A mistake made in the 13 field notes or in copying the field notes in the legislative process does not affect the district's: 14 15 (1) organization, existence, or validity; 16 (2) right to issue any type of bond for the purposes for which the district is created or to pay the principal of and 17 interest on a bond; 18 19 (3) right to impose a tax; or 20 (4) legality or operation. [Sections 8337.006-8337.050 reserved for expansion] 21 22 SUBCHAPTER B. BOARD OF DIRECTORS Sec. 8337.051. GOVERNING BODY; TERMS. (a) The district is 23 governed by a board of five elected directors. 24 25 (b) Except as provided by Section 8337.052, directors serve 26 staggered four-year terms.

The district has 4 the powers and duties necessary to accomplish the purposes for 5 which the district is created. 6 Sec. 8337.102. MUNICIPAL UTILITY DISTRICT POWERS AND 7 DUTIES. The district has the powers and duties provided by the general law of this state, including Chapters 49 and 54, Water Code, 8 9 applicable to municipal utility districts created under Section 59, Article XVI, Texas Constitution. 10 Sec. 8337.103. AUTHORITY FOR ROAD PROJECTS. (a) Under 11 12 Section 52, Article III, Texas Constitution, the district may 13 design, acquire, construct, finance, issue bonds for, improve, and convey to this state, a county, or a municipality for operation and 14 maintenance macadamized, graveled, or paved roads described by 15 Section 54.234, Water Code, or improvements, including storm 16 17 drainage, in aid of those roads. 18 (b) The district may exercise the powers provided by this section without submitting a petition to or obtaining approval from 19 20 the Texas Commission on Environmental Quality as required by Section 54.234, Water Code. 21 22 Sec. 8337.104. APPROVAL OF ROAD PROJECT. (a) The district 23 may not undertake a road project authorized by Section 8337.103 24 unless:

maintain the road has approved the plans and specifications of the

road project, if a municipality or county will operate and maintain

(1) each municipality or county that will operate and

1 the road; or 2 (2) the Texas Transportation Commission has approved 3 the plans and specifications of the road project, if the state will 4 operate and maintain the road. 5 (b) Except as provided by Subsection (a), the district is not required to obtain approval from the Texas Transportation 6 7 Commission to design, acquire, construct, finance, issue bonds for, 8 improve, or convey a road project. Sec. 8337.105. LIMITATION ON USE OF EMINENT DOMAIN. 9 district may not exercise the power of eminent domain outside the 10 11 district to acquire a site or easement for: (1) a road project authorized by Section 8337.103; or 12 13 (2) a recreational facility as defined by Section 14 49.462, Water Code. 15 [Sections 8337.106-8337.150 reserved for expansion] 16 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS 17 Sec. 8337.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The district may issue, without an election, bonds and other 18 obligations secured by: 19 20 (1) revenue other than ad valorem taxes; or 21 (2) contract payments described by Section 8337.153. 22 (b) The district must hold an election in the manner provided by Chapters 49 and 54, Water Code, to obtain voter approval 23 before the district may impose an ad valorem tax or issue bonds

- 23 revenue, contract payments, grants, or other district money, or any
- 24 combination of those sources, to pay for any authorized district

- Sec. 8337.202. TAXES FOR BONDS. At the time the district
- 27 issues bonds payable wholly or partly from ad valorem taxes, the

- 1 board shall provide for the annual imposition of a continuing
- 2 direct ad valorem tax, without limit as to rate or amount, while all
- 3 or part of the bonds are outstanding as required and in the manner
- 4 provided by Sections 54.601 and 54.602, Water Code.
- 5 Sec. 8337.203. BONDS FOR ROAD PROJECTS. At the time of
- 6 issuance, the total principal amount of bonds or other obligations
- 7 <u>issued or incurred to finance road projects and payable from ad</u>
- 8 valorem taxes may not exceed one-fourth of the assessed value of the
- 9 real property in the district.
- 10 SECTION 2. The Fort Bend County Municipal Utility District

- 8 SECTION 3. (a) The legal notice of the intention to

- 10 Act, has been published as provided by law, and the notice and a
- 11 copy of this Act have been furnished to all persons, agencies,
- 12 officials, or entities to which they are required to be furnished
- 13 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 14 Government Code.
- 15 (b) The governor, one of the required recipients, has
- 16 submitted the notice and Act to the Texas Commission on
- 17 Environmental Quality.
- 18 (c) The Texas Commission on Environmental Quality has filed
- 19 its recommendations relating to this Act with the governor, the
- 20 lieutenant governor, and the speaker of the house of
- 21 representatives within the required time.
- 22 (d) All requirements of the constitution and laws of this
- 23 state and the rules and procedures of the legislature with respect
- 24 to the notice, introduction, and passage of this Act are fulfilled
- 25 and accomplished.
- 26 SECTION 4. This Act takes effect immediately if it receives
- 27 a vote of two-thirds of all the members elected to each house, as

- 1 provided by Section 39, Article III, Texas Constitution. If this
- 2 Act does not receive the vote necessary for immediate effect, this
- 3 Act takes effect September 1, 2009.
