1 AN ACT 2 relating to inclusion in a public school campus improvement plan of 3 goals and objectives for the campus coordinated health program. Δ BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Subsection (d), Section 11.253, Education Code, 5 6 is amended to read as follows: 7 (d) Each campus improvement plan must: assess the academic achievement for each student 8 (1)in the school using the academic excellence indicator system as 9 10 described by Section 39.051; set the campus performance objectives based on the 11 (2) 12 academic excellence indicator system, including objectives for 13 special needs populations, including students in special education programs under Subchapter A, Chapter 29; 14 15 (3) identify how the campus goals will be met for each student; 16 (4) 17 determine the resources needed to implement the 18 plan; 19 (5) identify staff needed to implement the plan; set timelines for reaching the goals; 20 (6) 21 (7)measure progress toward the performance 22 objectives periodically to ensure that the plan is resulting in academic improvement; 23 include goals and methods for violence prevention 24 (8)

and intervention on campus; [and] 1 2 (9) provide for a program to encourage parental involvement at the campus; and 3 4 (10) if the campus is an elementary, middle, or junior high school, set goals and objectives for the coordinated health 5 6 program at the campus based on: 7 (A) student fitness assessment data, including any data from research-based assessments such as the school health 8 9 index assessment and planning tool created by the federal Centers for Disease Control and Prevention; 10 11 (B) student academic performance data; 12 (C) student attendance rates; 13 (D) the percentage of students who are 14 educationally disadvantaged; 15 (E) the use and success of any method to ensure 16 that students participate in moderate to vigorous physical activity as required by Section 28.002(1); and 17 18 (F) any other indicator recommended by the local school health advisory council. 19 20 SECTION 2. This Act applies beginning with the 2009-2010 21 school year. 22 SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 23 provided by Section 39, Article III, Texas Constitution. If this 24 Act does not receive the vote necessary for immediate effect, this 25 Act takes effect September 1, 2009. 26
