## A BILL TO BE ENTITLED

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 2158, Government Code, is amended by
- 6 adding Subchapter H to read as follows:
- 7 SUBCHAPTER H. PURCHASE OF UNITED STATES FLAG OR STATE FLAG
- 8 Sec. 2158.401. FLAG PROCUREMENT BY STATE GOVERNMENTAL
- 9 ENTITY. (a) In this subchapter, "state agency" means:
- 10 (1) a department, commission, board, office, or other
- 11 agency in the executive or legislative branch created by the
- 12 constitution or a statute of this state;
- 13 (2) the supreme court, the court of criminal appeals,
- 14 a court of appeals, or the Texas Judicial Council; or
- 15 (3) a university system or an institution of higher
- 16 education as defined by Section 61.003, Education Code.
- 17 (b) Each United States flag purchased by a state agency must
- 18 be manufactured in the United States.
- (c) Each Texas state flag purchased by a state agency must
- 20 <u>be manufactured in this state.</u>
- 21 (d) A flag is considered to have been manufactured in a
- 22 location if a substantial majority of the principal components are
- 23 assembled into the final product in an assembly plant in the
- 24 location.

- 1 SECTION 2. Subchapter Z, Chapter 271, Local Government
- 2 Code, is amended by adding Section 271.908 to read as follows:
- 3 Sec. 271.908. FLAG PROCUREMENT BY GOVERNMENTAL AGENCY. (a)
- 4 In this section, "governmental agency" has the meaning assigned by
- 5 Section 271.003.
- 6 (b) Each United States flag purchased by a governmental
- 7 agency must be manufactured in the United States.
- 8 <u>(c) Each Texas state flag purchased by a governmental agency</u>
- 9 must be manufactured in this state.
- 10 (d) A flag is considered to have been manufactured in a
- 11 location if a substantial majority of the principal components are
- 12 assembled into the final product in an assembly plant in the
- 13 location.
- 14 SECTION 3. Section 2158.401, Government Code, and Section
- 15 271.908, Local Government Code, as added by this Act apply only to
- 16 the purchase of a United States flag or Texas flag made or a
- 17 contract for the purchase of a United States flag or Texas flag
- 18 entered into on or after the effective date of this Act.
- 19 SECTION 4. This Act takes effect September 1, 2009.
