A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the continuation and operation of the office of public
- 3 insurance counsel.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 501.003, Insurance Code, is amended to
- 6 read as follows:
- 7 Sec. 501.003. SUNSET PROVISION. The office is subject to
- 8 Chapter 325, Government Code (Texas Sunset Act). Unless continued
- 9 in existence as provided by that chapter, the office is abolished
- 10 September 1, 2021 [2009].
- 11 SECTION 2. Section 501.054, Insurance Code, is amended to
- 12 read as follows:
- Sec. 501.054. LOBBYING ACTIVITIES. A person may not serve
- 14 as public counsel or act as general counsel to the office if the
- 15 person is required to register as a lobbyist under Chapter 305,
- 16 Government Code, because of the person's activities for
- 17 compensation on behalf of a profession related to the operation of
- 18 the department or the office.
- 19 SECTION 3. Section 501.102, Insurance Code, is amended to
- 20 read as follows:
- Sec. 501.102. TRADE ASSOCIATIONS. (a) In this section,
- 22 "Texas trade association" means a [nonprofit,] cooperative, [and]
- 23 voluntarily joined statewide association of business or
- 24 professional competitors in this state designed to assist its

- 1 members and its industry or profession in dealing with mutual
- 2 business or professional problems and in promoting their common
- 3 interest.
- 4 (b) A person may not serve as public counsel and may not [or]
- 5 be an office employee employed in a "bona fide executive,
- 6 administrative, or professional capacity," as that phrase is used
- 7 for purposes of establishing an exemption to the overtime
- 8 provisions of the federal Fair Labor Standards Act of 1938 (29
- 9 $\underline{\text{U.S.C.}}$ Section 201 et seq.), if [of the office who is exempt from
- 10 the state's position classification plan or is compensated at or
- 11 above the amount prescribed by the General Appropriations Act for
- 12 step 1, salary group A17, of the position classification salary
- 13 schedule if the person is]:
- 14 (1) the person is an officer, employee, or paid
- 15 consultant of a Texas trade association in the field of insurance;
- 16 or
- 17 (2) the person's spouse is [of] an officer, manager, or
- 18 paid consultant of a Texas trade association in the field of
- 19 insurance.
- 20 SECTION 4. Subchapter A, Chapter 501, Insurance Code, is
- 21 amended by adding Section 501.006 to read as follows:
- Sec. 501.006. TECHNOLOGY POLICY. The office shall
- 23 implement a policy requiring the office to use appropriate
- 24 technological solutions to improve the office's ability to perform
- 25 its functions. The policy must ensure that the public is able to
- 26 <u>interact with the office on the Internet.</u>
- 27 SECTION 5. Subchapter D, Chapter 501, Insurance Code, is

- 1 amended by adding Section 501.160 to read as follows:
- 2 Sec. 501.160. ALTERNATIVE DISPUTE RESOLUTION PROCEDURES.
- 3 (a) The office shall develop and implement a policy to encourage
- 4 the use of appropriate alternative dispute resolution procedures
- 5 under Chapter 2009, Government Code, to assist in the resolution of
- 6 internal and external disputes under the office's jurisdiction.
- 7 (b) The office's procedures relating to alternative dispute
- 8 resolution must conform, to the extent possible, to model
- 9 guidelines issued by the State Office of Administrative Hearings
- 10 for the use of alternative dispute resolution procedures by state
- 11 agencies.
- 12 <u>(c)</u> The office shall designate a trained person to:
- 13 (1) coordinate the implementation of the policy
- 14 adopted under Subsection (a);
- 15 (2) serve as a resource for training needed to
- 16 implement the alternative dispute resolution procedures; and
- 17 (3) collect data concerning the effectiveness of those
- 18 procedures as implemented by the office.
- 19 SECTION 6. Section 501.102, Insurance Code, as amended by
- 20 this Act, applies only to an appointment of public counsel that
- 21 occurs on or after the effective date of this Act. The change in the
- 22 qualifications for eligibility to serve as public counsel does not
- 23 affect the eligibility of a person serving as public counsel before
- 24 the effective date of this Act.
- 25 SECTION 7. This Act takes effect September 1, 2009.
