Section 54.06(e), Family Code, is amended to read as follows: 6 7 (e) The court shall apply the child support guidelines under Subchapter C, Chapter 154, in an order requiring the payment of 8 9 child support under this section. The court shall also require in an order to pay child support under this section that health 10 11 insurance and dental insurance be provided for the child. 12 Subchapter D, Chapter 154, applies to an order requiring health insurance and dental insurance for a child under this section. 13 14 SECTION 2. Section 101.006, Family Code, is amended to read as follows: 15 Sec. 101.006. CHILD SUPPORT SERVICES. 16 "Child support services" means administrative or court actions to: 17 18 establish paternity; establish, modify, or enforce child support, [or] 19 (2) medical support, or dental support obligations; 20 21 (3) locate absent parents; or 22 cooperate with other states in these actions and (4) 23 any other action authorized or required under Part D of Title IV of the federal Social Security Act (42 U.S.C. Section 651 et seq.) or 24

1 Chapter 231.

SECTION 3. Chapter 101, Family Code, is amended by adding
Sections 101.0094 and 101.0095 to read as follows:

<u>Sec. 101.0094. DENTAL INSURANCE. "Dental insurance" means</u>
 <u>insurance coverage that provides preventive dental care and other</u>
 <u>dental services, including usual dentist services, office visits,</u>
 <u>examinations, X-rays, and emergency services, that may be provided</u>
 <u>through a single service health maintenance organization or other</u>
 <u>private or public organization.</u>
 <u>Sec. 101.0095. DENTAL SUPPORT. "Dental support" means</u>

11 periodic payments or a lump-sum payment made under an order to cover 12 dental expenses, including dental insurance coverage, incurred for 13 the benefit of a child.

SECTION 4. Section 101.012, Family Code, is amended to read as follows:

16 Sec. 101.012. EMPLOYER. "Employer" means a person, 17 corporation, partnership, workers' compensation insurance carrier, governmental entity, the United States, or any other entity that 18 pays or owes earnings to an individual. The term includes, for the 19 purposes of enrolling dependents in a group health or dental 20 insurance plan, a union, trade association, or other similar 21 22 organization.

23 SECTION 5. Section 101.024(b), Family Code, is amended to 24 read as follows:

(b) For purposes of establishing, determining the terms of,
modifying, or enforcing an order, a reference in this title to a
parent includes a person ordered to pay child support under Section

1 154.001(a-1) or to provide medical support <u>or dental support</u> for a
2 child.

3 SECTION 6. Section 101.034, Family Code, is amended to read 4 as follows:

5 Sec. 101.034. TITLE IV-D CASE. "Title IV-D case" means an 6 action in which services are provided by the Title IV-D agency under 7 Part D, Title IV, of the federal Social Security Act (42 U.S.C. 8 Section 651 et seq.), relating to the location of an absent parent, 9 determination of parentage, or establishment, modification, or 10 enforcement of a child support, [or] medical support, or dental 11 <u>support</u> obligation.

SECTION 7. Section 153.611, Family Code, is amended to read as follows:

14 Sec. 153.611. EXCEPTION FOR CERTAIN TITLE IV-D 15 PROCEEDINGS. Notwithstanding any other provision of this subchapter, this subchapter does not apply to a proceeding in a 16 17 Title IV-D case relating to the determination of parentage or establishment, modification, or enforcement of a child support, 18 19 [or] medical support, or dental support obligation.

20 SECTION 8. Section 154.008, Family Code, is amended to read 21 as follows:

22 Sec. 154.008. PROVISION FOR MEDICAL SUPPORT <u>AND DENTAL</u> 23 <u>SUPPORT</u>. The court shall order medical support <u>and dental support</u> 24 for the child as provided by Subchapters B and D.

25 SECTION 9. Section 154.015(c), Family Code, is amended to 26 read as follows:

27

(c) For purposes of this section, the court of continuing

jurisdiction shall determine the amount of the unpaid child support obligation for each child of the deceased obligor. In determining the amount of the unpaid child support obligation, the court shall consider all relevant factors, including:

5 (1) the present value of the total amount of monthly 6 periodic child support payments that would become due between the 7 month in which the obligor dies and the month in which the child 8 turns 18 years of age, based on the amount of the periodic monthly 9 child support payments under the child support order in effect on 10 the date of the obligor's death;

11 (2) the present value of the total amount of health 12 insurance <u>and dental insurance</u> premiums payable for the benefit of 13 the child from the month in which the obligor dies until the month 14 in which the child turns 18 years of age, based on the cost of health 15 insurance <u>and dental insurance</u> for the child ordered to be paid on 16 the date of the obligor's death;

17 (3) in the case of a disabled child under 18 years of 18 age or an adult disabled child, an amount to be determined by the 19 court under Section 154.306;

(4) the nature and amount of any benefit to which the child would be entitled as a result of the obligor's death, including life insurance proceeds, annuity payments, trust distributions, social security death benefits, and retirement survivor benefits; and

(5) any other financial resource available for thesupport of the child.

27 SECTION 10. Section 154.016(b), Family Code, is amended to

1 read as follows:

2 (b) In determining the nature and extent of the obligation 3 to provide for the support of the child in the event of the death of 4 the obligor, the court shall consider all relevant factors, 5 including:

6 (1) the present value of the total amount of monthly 7 periodic child support payments from the date the child support 8 order is rendered until the month in which the child turns 18 years 9 of age, based on the amount of the periodic monthly child support 10 payment under the child support order;

11 (2) the present value of the total amount of health 12 insurance <u>and dental insurance</u> premiums payable for the benefit of 13 the child from the date the child support order is rendered until 14 the month in which the child turns 18 years of age, based on the cost 15 of health insurance <u>and dental insurance</u> for the child ordered to be 16 paid; and

17 (3) in the case of a disabled child under 18 years of 18 age or an adult disabled child, an amount to be determined by the 19 court under Section 154.306.

20 SECTION 11. Section 154.062(d), Family Code, is amended to 21 read as follows:

(d) The court shall deduct the following items from resources to determine the net resources available for child support:

25 (1) social security taxes;

26 (2) federal income tax based on the tax rate for a 27 single person claiming one personal exemption and the standard

(4) union dues; and

4 (5) expenses for the cost of health insurance, dental
5 insurance, [or] cash medical support, and cash dental support for

8 SECTION 12. Section 154.062(e), Family Code, as added by 9 Chapters 363 (S.B. 303) and 620 (H.B. 448), Acts of the 80th 10 Legislature, Regular Session, 2007, is reenacted and amended to 11 read as follows:

(e) In calculating the amount of the deduction for health care <u>or dental</u> coverage for a child under Subsection (d)(5), if the obligor has other minor dependents covered under the same health <u>or</u> <u>dental</u> insurance plan, the court shall divide the total cost to the obligor for the insurance by the total number of minor dependents, including the child, covered under the plan.

18 SECTION 13. Section 154.064, Family Code, is amended to 19 read as follows:

Sec. 154.064. MEDICAL SUPPORT <u>AND DENTAL SUPPORT</u> FOR CHILD PRESUMPTIVELY PROVIDED BY OBLIGOR. The guidelines for support of a child are based on the assumption that the court will order the obligor to provide medical support <u>and dental support</u> for the child in addition to the amount of child support calculated in accordance with those guidelines.

26 SECTION 14. The subchapter heading of Subchapter D, Chapter 27 154, Family Code, is amended to read as follows:

SUBCHAPTER D. MEDICAL SUPPORT <u>AND DENTAL SUPPORT</u> FOR CHILD
 SECTION 15. Subchapter D, Chapter 154, Family Code, is

<u>Sec. 154.1815. DENTAL SUPPORT ORDER. (a) In this section,</u>
<u>"reasonable cost" means the cost of a dental insurance premium that</u>

8 (b) In a suit affecting the parent-child relationship or in 9 a proceeding under Chapter 159, the court shall render an order for 10 the dental support of the child as provided by this section and 11 Section 154.1825.

12 (c) Before a hearing on temporary orders or a final order, if no hearing on temporary orders is held, the court shall require 13 the parties to the proceedings to disclose in a pleading or other 14 document whether the child is covered by dental insurance and, if 15 the child is covered, the identity of the insurer providing the 16 17 coverage, the policy number, which parent is responsible for payment of any insurance premium for the coverage, whether the 18 coverage is provided through a parent's employment, and the cost of 19 the premium. If dental insurance is not in effect for the child, 20 the parties must disclose to the court whether either parent has 21 access to dental insurance at a reasonable cost to that parent. 22

23 (d) In rendering temporary orders, the court shall, except 24 for good cause shown, order that any dental insurance coverage in 25 effect for the child continue in effect pending the rendition of a 26 final order, except that the court may not require the continuation 27 of any dental insurance that is not available to the parent at a

1 reasonable cost. If dental insurance coverage is not in effect for 2 the child or if the insurance in effect is not available at a reasonable cost, the court shall, except for good cause shown, 3 order dental insurance coverage for the child as provided by 4 Section 154.1825. 5 (e) On rendering a final order the court shall: 6 7 (1) make specific findings with respect to the manner 8 in which dental insurance coverage is to be provided for the child, in accordance with the priorities identified under Section 9 10 154.1825; and (2) except for good cause shown or on agreement of the 11 12 parties, require the parent ordered to provide dental insurance coverage for the child as provided by Section 154.1825 to produce 13 14 evidence to the court's satisfaction that the parent has applied 15 for or secured dental insurance or has otherwise taken necessary action to provide for dental insurance coverage for the child, as 16 17 ordered by the court. SECTION 16. Subchapter D, Chapter 154, Family Code, 18 is 19 amended by adding Section 154.1825 to read as follows: Sec. 154.1825. DENTAL CARE COVERAGE FOR CHILD. (a) In this 20 section, "reasonable cost" has the meaning assigned by Section 21 22 154.1815(a). (b) The court shall consider the cost and quality of dental 23 24 insurance coverage available to the parties and shall give priority to dental insurance coverage available through the employment of 25 26 one of the parties if the coverage is available at a reasonable 27 cost.

1 (c) In determining the manner in which dental care coverage 2 for the child is to be ordered, the court shall render its order in 3 accordance with the following priorities, unless a party shows good cause why a particular order is not in the best interest of the 4 5 child: 6 (1) if dental insurance is available for the child 7 through a parent's employment or membership in a union, trade association, or other organization at reasonable cost to the 8 parent, the court shall order that parent to include the child in 9 10 the parent's dental insurance; (2) if dental insurance is not available for the child 11 12 under Subdivision (1) but is available to a parent from another source and at a reasonable cost, the court may order that parent to 13 14 provide dental insurance for the child; or 15 (3) if dental insurance coverage is not available for the child under Subdivision (1) or (2), the court shall order the 16 17 obligor to pay the obligee, in addition to any amount ordered under the guidelines for child support, an amount, not to exceed three 18 percent of the obligor's annual resources, as described by Section 19 154.062(b), as cash dental support for the child. 20 21 (d) If the parent ordered to provide dental insurance under Subsection (c)(1) or (2) is the obligee, the court shall order the 22 obligor to pay the obligee, as additional child support, an amount 23 24 equal to the actual cost of dental insurance for the child. In calculating the actual cost of dental insurance for the child, if 25 26 the obligee has other minor dependents covered under the same dental insurance plan, the court shall divide the total cost to the 27

4	private dental insurance at a reasonable cost, the court shall

8	participation in any government medical assistance program or
9	health plan that provides dental coverage. If the child
10	participates in a government medical assistance program or health

27	Sec. 154.183. MEDICAL AND DENTAL SUPPORT ADDITIONAL SUPPORT

1 DUTY OF OBLIGOR. (a) An amount that an obligor is ordered to pay 2 as medical support <u>or dental support</u> for the child under this 3 chapter, including the costs of health insurance coverage or cash 4 medical support under Section 154.182 <u>and the costs of dental</u> 5 <u>insurance or cash dental support under Section 154.1825</u>:

6 (1) is in addition to the amount that the obligor is 7 required to pay for child support under the guidelines for child 8 support;

(2) is a child support obligation; and

26 (c) As additional child support, the court shall allocate 27 between the parties, according to their circumstances, the

1 reasonable and necessary:

2 (1) health care expenses of a child that are not 3 reimbursed by health insurance or are not otherwise covered by the 4 amount of cash medical support ordered under Section 154.182(b)(3); 5 and

6 (2) dental expenses of a child that are not reimbursed 7 by dental insurance or are not otherwise covered by the amount of 8 cash dental support ordered under Section 154.1825(b)(3).

9 SECTION 18. Sections 154.184(a) and (b), Family Code, are 10 amended to read as follows:

(a) Receipt of a medical support order requiring that health insurance be provided for a child <u>or a dental support order</u> <u>requiring dental insurance be provided for a child</u> shall be considered a change in the family circumstances of the employee or member, for health insurance purposes <u>and dental insurance</u> <u>purposes</u>, equivalent to the birth or adoption of a child.

(b) If the employee or member is eligible for dependent health coverage <u>or dependent dental coverage</u>, the employer shall automatically enroll the child for the first 31 days after the receipt of the order or notice of the medical support order <u>or the</u> <u>dental support order</u> under Section 154.186 on the same terms and conditions as apply to any other dependent child.

25 Sec. 154.185. PARENT TO FURNISH INFORMATION. (a) The court 26 shall order a parent providing health insurance <u>or dental insurance</u> 27 to furnish to either the obligee, obligor, or child support agency

directing that health insurance coverage <u>or dental insurance</u>
<u>coverage</u> be provided to a child of an employee or member is binding
on a current or subsequent employer on receipt without regard to the

11 (b) If additional premiums are incurred as a result of 12 adding the child to the health insurance plan <u>or the dental</u> 13 <u>insurance plan</u>, the employer shall deduct the health insurance 14 premium <u>or the dental insurance premium</u> from the earnings of the 15 employee in accordance with Chapter 158 and apply the amount 16 withheld to payment of the insurance premium.

17 (c) An employer who has received an order or notice under 18 this subchapter shall provide to the sender, by first class mail not 19 later than the 30th day after the date the employer receives the 20 order or notice, a statement that the child:

(1) has been enrolled in a health insurance plan or
 <u>dental insurance plan</u>; or

(2) cannot be enrolled or cannot be enrolled

25 provide the reason why coverage or permanent coverage cannot be

(d) If the employee ceases employment or if the health

insurance coverage <u>or dental insurance coverage</u> lapses, the employer shall provide to the sender, by first class mail not later than the 15th day after the date of the termination of employment or the lapse of the coverage, notice of the termination or lapse and of

6 (e) On request, the employer shall release to the sender 7 information concerning the available health insurance coverage <u>or</u> 8 <u>dental insurance coverage</u>, including the name of the health 9 insurance carrier <u>or dental insurance carrier</u>, the policy number, a 10 copy of the policy and schedule of benefits, a health insurance 11 membership card, and claim forms.

(g) An employer who fails to enroll a child, fails to withhold or remit premiums or cash medical support <u>or dental</u> <u>support</u>, or discriminates in hiring or employment on the basis of a medical support order <u>or a dental support order</u> or notice under this subchapter shall be subject to the penalties and fines in Subchapter C, Chapter 158.

SECTION 23. Section 154.188, Family Code, is amended to read as follows:

Sec. 154.188. FAILURE TO PROVIDE OR PAY FOR REQUIRED HEALTH INSURANCE <u>OR DENTAL INSURANCE</u>. A parent ordered to provide health insurance <u>or dental insurance</u> or to pay the other parent additional child support for the cost of health insurance <u>or dental insurance</u> who fails to do so is liable for:

(1) necessary medical expenses <u>or dental expenses</u> of
the child, without regard to whether the expenses would have been
paid if health insurance <u>or dental insurance</u> had been provided; and

(2) the cost of health insurance premiums, dental
 <u>insurance premiums</u>, or contributions, if any, paid on behalf of the
 child.

4 SECTION 24. Section 154.189, Family Code, is amended to 5 read as follows:

6 Sec. 154.189. NOTICE OF TERMINATION OR LAPSE OF INSURANCE 7 COVERAGE. (a) An obligor ordered to provide health insurance 8 coverage <u>or dental insurance coverage</u> for a child must notify the 9 obligee and any child support agency enforcing a support obligation 10 against the obligor of the:

(1) termination or lapse of health insurance coverage or dental insurance coverage for the child not later than the 15th day after the date of a termination or lapse; and

14 (2) availability of additional health insurance or
15 <u>dental insurance</u> to the obligor for the child after a termination or
16 lapse of coverage not later than the 15th day after the date the
17 insurance becomes available.

(b) If termination of coverage results from a change of employers, the obligor, the obligee, or the child support agency may send the new employer a copy of the order requiring the employee to provide health insurance <u>or dental insurance</u> for a child or notice of the medical support order <u>or the dental support order</u> as provided by this subchapter.

24 SECTION 25. Section 154.190, Family Code, is amended to 25 read as follows:

26 Sec. 154.190. REENROLLING CHILD FOR INSURANCE COVERAGE. 27 After health insurance <u>or dental insurance</u> has been terminated or

1 has lapsed, an obligor ordered to provide health insurance coverage 2 <u>or dental insurance coverage</u> for the child must enroll the child in 3 a health insurance plan <u>or a dental insurance plan</u> at the next 4 available enrollment period.

5 SECTION 26. Section 154.191, Family Code, is amended to 6 read as follows:

Sec. 154.191. REMEDY NOT EXCLUSIVE. (a) This subchapter does not limit the rights of the obligor, obligee, local domestic relations office, or Title IV-D agency to enforce, modify, or clarify the medical support order or dental support order.

(b) This subchapter does not limit the authority of the court to render or modify a medical support order <u>or dental support</u> <u>order</u> containing a provision for payment of uninsured health expenses, health care costs, [or] health insurance premiums, <u>uninsured dental expenses, dental costs, or dental insurance</u> <u>premiums</u> that are in addition to and inconsistent with this subchapter.

SECTION 27. Section 154.192, Family Code, is amended to read as follows:

Sec. 154.192. CANCELLATION OR ELIMINATION OF INSURANCE COVERAGE FOR CHILD. [(a)] Unless the employee or member ceases to be eligible for dependent coverage, or the employer has eliminated dependent health coverage <u>or dental coverage</u> for all of the employer's employees or members, the employer may not cancel or eliminate coverage of a child enrolled under this subchapter until the employer is provided satisfactory written evidence that:

27 (1) the court order or administrative order requiring

1 the coverage is no longer in effect; or

2 (2) the child is enrolled in comparable [health] 3 insurance coverage or will be enrolled in comparable coverage that 4 will take effect not later than the effective date of the 5 cancellation or elimination of the employer's coverage.

8 (a) If a plan administrator or other person acting in an 9 equivalent position determines that a medical support order <u>or</u> 10 <u>dental support order</u> issued under this subchapter does not qualify 11 for enforcement under federal law, the tribunal may, on its own 12 motion or the motion of a party, render an order that qualifies for 13 enforcement under federal law.

SECTION 29. Section 156.401(a), Family Code, is amended to read as follows:

(a) Except as provided by Subsection (a-1) or (b), the court
may modify an order that provides for the support of a child,
including an order for health care coverage under Section 154.182
or an order for dental care coverage under Section 154.1825, if:

20 (A) is enrolled in comparable health <u>or dental</u>
21 coverage; or

(B) will be enrolled in comparable health or
 <u>dental</u> coverage that takes effect not later than the effective date
 of the cancellation or nonrenewal.

(b) For purposes of this section, a child is not enrolled or entitled to enrollment under this chapter if the child's eligibility for health <u>or dental</u> coverage ends because the parent

1 ceases to be eligible for dependent health or dental coverage.

2 SECTION 66. Section 1504.054, Insurance Code, is amended to 3 read as follows:

Sec. 1504.054. CONTINUATION OR CONVERSION OF COVERAGE. (a) 4 If a child's eligibility for dependent health or dental coverage 5 ends because the parent ceases to be eligible for the coverage and 6 the coverage provides for the continuation or conversion of the 7 8 coverage for the child, the [health] benefit plan issuer shall notify the custodial parent and the child support agency of the 9 10 costs and other requirements for continuing or converting the coverage. 11

(b) The [health] benefit plan issuer shall, on application of a parent of the child, a child support agency, or the child, enroll or continue enrollment of a child whose eligibility for coverage ended under Subsection (a).

16 SECTION 67. Section 1504.055, Insurance Code, is amended to 17 read as follows:

Sec. 1504.055. PROCEDURE FOR CLAIMS. (a) A [health]
benefit plan issuer that provides health <u>or dental</u> coverage to a
child through a covered parent of the child shall:

(1) provide to each custodial parent of the child or to an adult child documents and other information necessary for the child to obtain benefits under the coverage, including:

(A) the name of the issuer;(B) the number of the policy or evidence of

26 coverage;

(C) a copy of the policy or evidence of coverage

1 and schedule of benefits;

2 (D) a health or dental coverage membership card;

3 (E) claim forms; and

4 (F) any other document or information necessary 5 to submit a claim in accordance with the issuer's policies and 6 procedures;

7 (2) permit a custodial parent, health care provider, 8 state agency that has been assigned medical <u>or dental</u> support 9 rights, or adult child to submit claims for covered services 10 without the approval of the covered parent; and

(3) make payments on covered claims submitted in accordance with this subsection directly to a custodial parent, health care provider, adult child, or state agency making a claim.

(b) A [health] benefit plan issuer shall provide to a state agency that provides medical assistance, including medical <u>assistance for dental services</u>, to the child or shall provide to a child support agency that enforces medical <u>or dental</u> support on behalf of a child the information necessary to obtain reimbursement of medical <u>or dental</u> services provided to or paid on behalf of the child.

21 SECTION 68. Section 1504.101, Insurance Code, is amended to 22 read as follows:

23 Sec. 1504.101. DENIAL OF ENROLLMENT ON CERTAIN GROUNDS 24 PROHIBITED. A [health] benefit plan issuer may not deny enrollment 25 of a child under the health <u>or dental</u> coverage of the child's parent 26 on the ground that the child:

has a preexisting condition;

(2) was born out of wedlock;

2 (3) is not claimed as a dependent on the parent's3 federal income tax return;

(4) does not reside with the parent; or

(5) receives or has applied for medical assistance.

6 SECTION 69. Section 1504.102, Insurance Code, is amended to 7 read as follows:

Sec. 1504.102. ASSIGNMENT OF MEDICAL OR DENTAL SUPPORT 8 RIGHTS: DIFFERENT REQUIREMENTS PROHIBITED. A [health] benefit 9 10 plan issuer may not require a state agency that has been assigned the rights of an individual who is eligible for medical assistance 11 and is covered for health or dental benefits from the issuer to 12 comply with a requirement that is different from a requirement 13 14 imposed on an agent or assignee of any other covered individual.

15 SECTION 70. (a) The changes in law made by this Act apply to 16 a suit affecting the parent-child relationship filed on or after 17 the effective date of this Act. A suit affecting the parent-child 18 relationship filed before the effective date of this Act is 19 governed by the law in effect on the date the suit was filed, and the 20 former law is continued in effect for that purpose.

(b) The change in law made by this Act does not by itself constitute a material and substantial change of circumstances under Section 156.401, Family Code, sufficient to warrant modification of a court order or a portion of a decree that provides for the support of a child rendered before the effective date of this Act.
