6 released only to the extent the information is not excepted from
7 required disclosure under this subchapter or Subchapter C.

8 <u>(d) For purposes of this section, "benefits" does not</u> 9 <u>include pension benefits provided to an individual by a pension</u> 10 <u>system under the statutory plan covering the individual as a</u> 11 <u>member, beneficiary, or retiree of the pension system.</u>

12 SECTION 2. Section 552.0221, Government Code, as added by 13 this Act, applies only in relation to a request for public 14 information made on or after the effective date of this Act.

15 SECTION 3. This Act takes effect immediately if it receives 16 a vote of two-thirds of all the members elected to each house, as 17 provided by Section 39, Article III, Texas Constitution. If this 18 Act does not receive the vote necessary for immediate effect, this 19 Act takes effect September 1, 2009.
