Subchapter B, Chapter 56, Education Code, is amended by adding Section 56.014 to read as follows: 1-16 Sec. 56.014. NOTICE TO STUDENTS REGARDING TUITION SET ASIDE FOR FINANCIAL ASSISTANCE. (a) An institution of higher education 1-17 1-18 that is required by this subchapter to set aside a portion of the 1**-**19 1**-**20 tuition paid by a student to provide financial assistance for students enrolled in the institution shall provide to each student 1-21 of the institution who pays tuition from which a portion is required 1-22 to be set aside for that purpose a notice of the amount of the tuition paid by the student that is required to be set aside.
