18	including an individual, group, blanket, or franchise insurance
19	policy or insurance agreement, a group hospital service contract,

ADMINISTERED ANTICANCER MEDICATIONS. A health benefit plan that provides coverage for chemotherapy treatment of cancer must provide coverage for a prescribed, orally administered anticancer medication that is used to kill or slow the growth of cancerous cells on a basis no less favorable than intravenously administered or injected cancer medications that are covered as medical benefits by the plan.

8 SECTION 2. Subchapter E, Chapter 1369, Insurance Code, as 9 added by this Act, applies only to a health benefit plan that is 10 delivered, issued for delivery, or renewed on or after January 1, 11 2010. A health benefit plan that is delivered, issued for delivery, 12 or renewed before January 1, 2010, is covered by the law in effect 13 at the time the plan was delivered, issued for delivery, or renewed, 14 and that law is continued in effect for that purpose.
