A BILL TO BE ENTITLED

2	relating to the provision of information regarding health care and
3	other benefits for veterans and their family members.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 434, Government Code, is
6	amended by adding Section 434.019 to read as follows:
7	Sec. 434.019. INFORMATION ABOUT VETERANS BENEFITS. The
8	Texas Veterans Commission shall, to the extent possible:
9	(1) attend each transition assistance program
10	conducted by the United States Department of Defense in the state;
11	<u>and</u>
12	(2) at each transition assistance program:
13	(A) distribute the application for health
14	benefits from the United States Department of Veterans Affairs; and
15	(B) answer questions regarding health care and
16	other benefits available to veterans of the United States armed
17	forces.
18	SECTION 2. The heading to Section 531.093, Government Code,
19	is amended to read as follows:

- Sec. 531.093. SERVICES FOR <u>SERVICEMEMBERS AND FAMILY OF</u>
- 21 <u>SERVICEMEMBERS</u> [<u>MILITARY PERSONNEL</u>].
- SECTION 3. Subsection (b), Section 531.093, Government
- 23 Code, is amended to read as follows:
- 24 (b) The executive commissioner shall ensure that each

- 1 health and human services agency adopts policies and procedures
- 2 that require the agency to:
- 3 (1) identify the following individuals
- 4 [servicemembers] who are seeking services from the agency during
- 5 the agency's intake and eligibility determination process:
- 6 (A) servicemembers;
- 7 (B) spouses of servicemembers;
- 8 (C) spouses of deceased servicemembers; and
- 9 (D) dependents of deceased servicemembers; and
- 10 (2) direct the individuals identified under
- 11 <u>Subdivision (1)</u> [servicemembers seeking services] to appropriate
- 12 service providers, including the United States Veterans Health
- 13 Administration, National Guard Bureau facilities, and other
- 14 federal, state, and local service providers.
- 15 SECTION 4. Subchapter U, Chapter 161, Health and Safety
- 16 Code, is amended by adding Section 161.553 to read as follows:
- 17 Sec. 161.553. VETERANS HEALTH CARE BENEFITS. (a) The
- 18 department and commission shall ensure that each individual who
- 19 calls the Texas Information and Referral Network is informed that
- 20 individuals who are servicemembers, spouses of servicemembers,
- 21 spouses of deceased servicemembers, or dependents of deceased
- 22 servicemembers may be entitled to medical and other benefits from
- 23 the United States Department of Veterans Affairs, the National
- 24 Guard Bureau, and other federal, state, and local service
- 25 providers.
- 26 (b) The Texas Information and Referral Network shall
- 27 provide the name and contact information of each entity that

- 1 provides benefits to which an individual described by Subsection
- 2 (a) may be entitled.
- 3 (c) The Texas Veterans Commission shall cooperate with the
- 4 department and commission in preparing and maintaining the
- 5 information relating to referrals that is provided through the
- 6 Texas Information and Referral Network, as provided by this
- 7 section.
- 8 SECTION 5. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2009.
