Section 1395i-4; 10 (2) is a sole community hospital, as that term is 11 12 defined by 42 U.S.C. Section 1395ww(d)(5)(D)(iii); or 13 (3) is located in a county with a population of 50,000 14 or less. EMPLOYMENT OF PHYSICIAN PERMITTED. 15 (a) Α 16 hospital may employ a physician and retain all or part of the professional income generated by the physician for medical services 17 provided at the hospital. 18 (b) A hospital located in a county with a population of 19 50,000 or less may continue to employ any physicians employed by the 20 hospital on or before the date of release of a federal decennial 21 census that shows the county's population exceeds 50,000. The 22 23 hospital may not employ a new physician after that date. Sec. 311.063. HOSPITAL POLICIES. (a) A hospital shall 24

2	under this subchapter whose professional income is retained under

5	(b) The policies adopted under this section must include
6	policies relating to:

8	(2) quality assurance;
9	(3) utilization review;

13	Sec. 311.064. CREDENTIALING AND PRIVILEGES. (a) A
14	physician employed by a hospital is subject to the same standards
15	and procedures regarding credentialing, peer review, quality of
16	care, and privileges as a physician not employed by the hospital.
17	(b) A hospital shall give equal consideration regarding the
18	issuance of credentials and privileges to physicians employed by
19	the hospital and physicians not employed by the hospital.
20	Sec. 311.065. OTHER HOSPITAL-PHYSICIAN RELATIONSHIPS.
21	This subchapter may not be construed as altering, voiding, or
22	prohibiting any relationship between a hospital and a physician,
23	including a contract or arrangement with an approved nonprofit
24	health corporation that is certified under Section 162.001(b),
25	Occupations Code, and that holds a certificate of authority issued
26	under Chapter 844, Insurance Code.
27	SECTION 2. This Act takes effect September 1, 2009.
